The Honourable Mr Justice Dove :

Introduction

- 1. This is an application for Judicial Review in relation to the Defendants' actions in respect of cotton produced in the Xinjiang Uyghur Autonomous Region ("XUAR"). The Claimant is a non-governmental organisation ("NGO") that aims to promote the collective interests of the Uyghur people. The particular concern of the Claimant which has led to the commencement of this litigation are the crimes and human rights abuses committed by the government of the People's Republic of China ("the PRC") in XUAR against the Uyghur people in the production of cotton which is exported out of China to, amongst other destinations, the UK.
- 2. The Defendants are agencies which are concerned, amongst other statutory functions and in so far as is relevant to the present proceedings, with law enforcement in particular in relation to the supervision of the borders of the UK. The nature and function of the respective Defendants are as follows. The First Defendant created what is now known as 'Border Force' (formerly the UK Border Agency) in 2009. Border Force is a law enforcement command within the Home Office, which has operational responsibility for customs and revenue work at the border. The Second Defendant is the UK Customs Authority and retains overall responsibility for customs and revenue policy. However, operational customs activity at the border is a matter for Border Force, whereas the Second Defendant is primarily concerned with customs and taxation matters inland. The Third Defendant is responsible for the investigation of serious and organised crime in the UK. It conducts such investigations with a view to criminal prosecutions and proceedings for civil recovery.
- 3. The Claimant's case has two legal themes. The first two grounds of their case relate to section 1 of the Foreign Prison-Made Goods Act 1897. Ground 1 is the contention that Defendants' decision not to investigate potential breaches of section 1 of the 1897 Act is based on a misdirection of law, in that they have misunderstood what is required in evidential terms to establish a breach of that section. The Claimant's Ground 2 is the submission that the First Defendant (via Border Force) unlawfully fettered its discretion to investigate potential breaches of section 1 of the 1897 Act in that its policy is to respond to evidence on a "reactive basis" only, rather than launching its own proactive investigations.
- 4. The second legal theme relates to the provisions of the Proceeds of Crime Act 2002. In particular, the Second and Third Defendants failed to launch investigations under Part 7 of the 2002 Act based upon a misdirection of law as to the scope of the powers under that part of the Act: this is Ground 3 of the Claimant's case. Ground 4 is a similar contention in respect of a misdirection of law about the powers of civil recovery of property under Part 5 of the 2002 Act. In essence, as set out below, the central concern of the Claimant under both of these grounds is the Defendants' view that there is a need for specific criminal property to be identified prior to an investigation being launched under the 2002 Act.
- 5. The Claimant's case under Grounds 1 and 2 were advanced by Ms Jenni Richards KC and Ms Katherine Barnes; their case in relation to Grounds 3 and 4 were developed by Mr Tom Forster KC, Ms Anita Clifford and Mr Russell Hopkins. On behalf of the Defendants, the response to the Claimant's case under Grounds 1 and 2 (including some cross-cutting submissions in relation to evidence) was advanced by Sir James Eadie KC; the Defendants' submissions in respect of Grounds 3 and 4 were made by Mr David Perry KC and Ms Katherine Hardcastle. I am very grateful to the legal teams on all sides of the case for the great care which was brought to bear on the preparation of the papers in the case for the hearing and for the clear and focussed submissions in the text of the judgment to either the Claimant or the Defendant (using that term collectively for all of the Defendants identified above), but have done so for the sake of simplicity and clarity.

The Background Facts

- 6. The Uyghur people are an ethnically and culturally Turkic people living in the XUAR or East Turkistan. Historically there have been tensions between the indigenous inhabitants of the XUAR and the PRC, which led in 2014 to the PRC launching a "People's War on Terror", followed by the implementation of large-scale measures to secure control of the Uyghur and other Turkic people in the XUAR. These measures included the internment and "reeducation" of vast numbers of citizens accompanied by correctional forced labour alongside birth prevention and family separation. The activities of the extensive cotton and textile industry in XUAR are integrally involved in the repressive measures implemented by the PRC. The evidence before the court explains that 30% of the world's production of cotton originates in the PRC, and of that 85% originates in the Xinjiang or XUAR. The repressive measures affecting the Uyghurs include forcing them to pick cotton, to work in textile factories either inside or adjacent to the internment camps, as well as forcing them to live and work under coercive conditions in textile industrial parks which are referred to below both in XUAR and elsewhere in PRC. In addition, the evidence records that prison inmates are routinely used to provide labour to support cotton production at other parts of the value chain.
- 7. The Claimant's case draws attention by way of illustration to a sample of evidence which demonstrates the relationship between the PRC's minority control measures and the Xinjiang Aid programme which is associated with these measures and the production of cotton in the XUAR. By way of example the evidence records as a case study Aksu industrial park in the Aksu Prefecture, Xinjiang. This facility features in reports of research and policy organisations as well as in articles based on investigative journalism. The Centre for Strategic and International Studies in its report "Connecting the Dots in Xinjiang: Forced Labor, Forced Assimilation, and Western Supply Chains" describes the Aksu Industrial Park as a "key element of the government's poverty alleviation program" and notes that it is part of an initiative to reach 100 villages in the Aksu area and build about 1000 factories of over 1 million square meters by 2020. The Wall Street Journal visited Aksu and reported that in the two years prior to their visit, PRC officials had gathered up more than 4,000 residents for deradicalization and textile-making courses in "concentrated, closed-off, military-style management", in order to meet the labour requirements of the manufacturers.
- 8. The Aksu Industrial Park also features in the 2021 Xinjiang Cotton Textile Industry Social Responsibility Report published by the Xinjiang authorities to portray the Minority Control Measures in a positive light. This report notes that by developing an Industrial City it has brought together the whole industrial value chain (including spinning, printing, dyeing, weaving and the production of textiles and garments) and represents an important base for "Xinjiang to drive the transfer of the surplus rural labour force in the four prefectures in south Tianshan Mountain. Thanks to the cotton textile businesses, a barren desert in the past has turned into a livable modern industrial city."
- 9. The Claimant's evidence sets out that the Industrial Parks which are part of the Xinjiang Aid programme are supported by forced labour in which Uyghurs and other Turkic people live and work under conditions of detention. The satellite images of these facilities show buildings which appear to be residential along with the factory buildings. The Claimant's evidence goes on to describe the Chinese textile companies that are implicated in the use of Uyghur forced or prison labour in the production and distribution of cotton. One of these, Huafu, is a company which opened a major production facility in Aksu in 2018. The facility is the world's largest textile mill for coloured yarns. A report from the CSIS notes that Huafu run a training college at the Aksu Industrial Park next to its factory, which is said to operate training programmes with government subsidies "intended to eradicate their extremist thoughts" for workers who are then employed in the factory.
- 10. Adrian Zenz, a journalist who has studied the cotton industry in the XUAR, states that Huafu is part of an official training initiative subjecting Uyghurs to centralised "military drill, thought transformation...and deextremification". Entire families, he reports, live in company

dormitories whilst the parents work and their children attend the Huafu school. Large amounts of government subsidies are received by Huafu for training and employing minorities. Huafu are, therefore, said to play their part in a policy of rounding up adults from the rural areas, and then conscripting them in training programmes to equip them to work in cotton industry factories as well as providing them with political indoctrination, before putting them to work in textile factories.

- 11. The Claimant's evidence goes on to note that a company with a significant UK presence has listed Huafu's mainland manufacturing facility in Zhejiang as a supplier, it is presumed on the basis that this factory is in parallel to, but not tainted by, the cotton manufactured at Aksu. However, the evidence goes on to observe that Huafu boast of an integrated vertical chain of fabrication and that there are real difficulties in relying upon any assurances as to cotton being produced in the XUAR.
- 12. The evidence notes that in the past whilst some global retailers would admit to sourcing cotton from the XUAR, they would rely upon the assurance of the Better Cotton Initiative ("BCI") (a not-for-profit organisation operating a cotton sustainability programme which carries out assurance and licensing activities in relation to cotton production and manufacture) that forced labour did not taint supply chains involving cotton from the XUAR. That is no longer the case. In March 2020 BCI announced that it was suspending its assurance in relation to cotton produced in the XUAR and had commissioned a review of the situation by an independent expert. In October 2020 BCI announced that in the light of the sustained allegations of forced labour and human rights abuses in the XUAR it was ceasing all field activities in the XUAR with immediate effect. There was no production facility or factory in the XUAR which had been independently verified as not using forced labour. On 29th October 2020 BCI published findings of the independent expert which concluded that BCI should end all operations and business relationships in the XUAR as a result, in essence, of the credible evidence of the scale of forced labour in the XUAR, coupled with the impossibility of conducting assurance activities and the credible evidence of human rights abuses in the XUAR. As the Claimant's evidence sets out, this follows from extensive problems (including being detained, harassed and threatened) experienced by those attempting to audit the activities of the cotton industry in the XUAR.
- 13. In addition to Huafu the Claimant's evidence also highlights the activities of other Chinese companies in the XUAR, in particular Ruyi Group, Litai Textiles and LuThai Group. It is not necessary for the purposes of this judgment to set out all of the evidence in relation to these companies, but akin with the approach taken in the Claimant's skeleton argument it is worthwhile focussing on the position of LuThai Group as an example of how these companies are implicated in the supply chain for cotton goods.
- 14. The LuThai Group is a collection of companies which is engaged in the manufacture of highgrade varn dved fabrics, with a complete industrial chain from varn spinning through to garment making and marketing. In a report published by the NGO Citizen Power Initiatives for China ("CPI") LuThai Group are identified as actively participating in the CCP's textile programmes in the XUAR. The report quotes one of LuThai's executives explaining their dependence upon the "large surplus of labor in the local rural areas that can meet the needs of our company." The annual reports of the company confirm that subsidiaries based in Aksu City were involved in the planting and processing of cotton for its parent company. Further, the 2018 LuThai Social Responsibility Report sets out that it has been involved in the construction of a 100,000-spindle cotton spinning project in the Aksu region, increasing their capacity to 228,000 spindles, and thereby solving various problems "including the employment of local surplus labors without having to go far" and promoting common development. Other sources confirm the significant increase in production of cotton by LuThai in the XUAR from 2013 onwards, including in particular the period from 2017 shortly after the PRC introduced the control measures in the XUAR. For instance, in 2017 itself the

sales volume of cotton recorded in the LuThai annual report increased by 241% compared with the previous year.

- 15. It appears that the LuThai Group's parent company sold its majority stake in its main XUAR subsidiary in 2020, potentially as a result of the concerns expressed about conditions in the XUAR by foreign buyers. Nevertheless, the 2020 annual report continued to account for the same amount of subsidies received for transferring Xinjiang cotton out of Xinjiang, suggesting strongly that LuThai were continuing to source cotton from the XUAR company even though it no longer owned it.
- 16. The Claimant's evidence sets out that the Open Apparel Registry (which lists facilities used by companies derived from their published supplier lists) states that a number of UK companies have named LuThai's Shandong factory as amongst their suppliers, the Shandong fabric mill being a manufacturing facility which uses cotton and lint from the XUAR based on the integrated approach which the company takes to its operations.
- 17. The evidence underlying the Claimant's case in relation to the mistreatment of the Uyghur people and the involvement of abuses in the production of cotton in the XUAR is not the subject of dispute by the Defendants. The nature of the agreement is underlined by public statements on behalf of the UK Government. In an oral statement to Parliament on 12 January 2021, the then Foreign Secretary shared the UK Government's response to the ongoing situation:

"The evidence of the scale and the severity of the human rights violations being perpetrated in Xinjang against the Uyghur Muslims is now far-reaching, and it paints a truly harrowing picture.

Violations include the extra-judicial detention of over a million Uyghurs and other minorities in political reeducation camps. Extensive and invasive surveillance targeting minorities. Systematic restrictions on Uyghur culture, education and indeed the practice of Islam, and the widespread use of forced labour.

The nature and conditions of detention violate basic standards of human rights, and at their worst amount to torture and inhumane and degrading treatment. Alongside widespread reports of the forced sterilisation of Uyghur women.

These claims are supported now by a large, diverse and growing body of evidence. That includes:

- first hand reports from diplomats who visit Xinjiang, the first hand testimony from victims who have fled the region
- there is satellite imagery showing the scale of the internment camps, the presence of factories inside them, and the destruction of mosques
- and there are also extensive and credible third party reports from NGOs such as Human Rights Watch and Amnesty International, with the UN and other international experts also expressing their very serious concerns.

In reality, the Chinese authorities' own publicly-available documents also bear out a very similar picture. They show statistical data on birth control and on security spending and recruitment in Xinjiang. They contain extensive references to coercive social measures, dressed up as poverty alleviation programmes.

There are leaks of classified and internal documents that have shown the guidance on how to run internment camps, lists showing how and why people have been detained. Internment camps, arbitrary detention, political re-education, forced labour, torture and forced sterilisation. All on an industrial scale. It is truly horrific. Barbarism we had hoped lost to another era, being practised today, as we speak, in one of the leading members of the international community.

•••

Xinjiang's position in the international supply chain network means that there is a real risk of businesses and public bodies around the world – whether it's inadvertently or otherwise – sourcing from suppliers which are complicit in the use of forced labour. Allowing those responsible for these violations to profit, or indeed making a profit themselves by supplying the authorities in Xinjiang.

Mr Speaker, here in the UK, we must take action, to make sure that UK businesses are not part of the supply chains that lead to the gates of the internment camps in Xinjiang. And to make sure that the products of the human rights violations that take place in those camps don't end up on the shelves of supermarkets that we shop in here at home, week in week out."

18. On 8th July 2021 the House of Commons Foreign Affairs Committee ("FAC") published its report "Never Again: The UK's Responsibility to Act on Atrocities in Xianjiang and Beyond". The report addressed the link between the cotton industry and human rights violations against Uyghurs in the XUAR. Within the report, which was wide-ranging in its scope and recommendations, the following was set out:

"39. Many people who 'graduate' from the internment camp system are coerced into state-organised forced labour programmes. Between 2017-2019 alone, more than 80,000 Uyghurs were forcibly transferred out of Xinjiang to work in factories across China, under the Xinjiang Aid programme. More recent estimates suggest that at least 570,000 people from Xinjiang have been forced to pick cotton. Workers are typically paid little to nothing. Satellite imagery reveals factories surrounded by barbed wire fences, surveillance cameras, and guard towers. 84% of China's cotton comes from Xingjiang, and China provides a quarter of the world's cotton products.

40. With these facts in mind, we are seriously concerned that products and materials made from Uyghur forced labour are making their way into UK value chains. We heard that "virtually the entire" UK textile and clothing industry is linked to the abuses in Xinjiang...

46. Throughout the course of this inquiry, we have heard that the issue of forced labour in Xinjiang is pervasive, widespread, and extremely difficult to monitor effectively. Outside auditors are regularly denied access to Xinjiang factories and forced labourworkers are coerced into silence. Because of this, the United States announced a ban on cotton products from Xinjiang in January 2021. Certain businesses have taken similar measures.

47. Private companies such as ASOS, River Island, and NEXT told us they were taking steps to reduce the risk of using cotton sourced from Xinjiang, although NEXT disclosed at the time that it was "likely" that there was "some" Xinjiang cotton in their products. On the likelihood of Xinjiang produce being sourced from forced labour, Primark told us:

'Our initial response to the situation in Xinjiang began in October 2019, when we made the decision to end our relationship with the only factory from which we sourced finished goods in the XUAR...We believe our position is appropriate and proportionate given the reports which have emerged regarding alleged human rights abuses and the use of forced labour in Xinjiang, and because we are unable to

undertake the due diligence or auditing that we would normally carry out when such claims emerge.'

48. Unless proven otherwise, the mass incarcerations and connected factories and farms mean it should be assumed that any product originating from Xinjiang is the product of forced labour. While much focus has been placed on the textile and apparel sector, other areas such as solar energy, agriculture, and electronics also bear a substantial risk of forced labour. Until there can be definitive proof that products are not tainted by forced labour, UK companies and consumers should not be purchasing them. The Government should explore the possibility of banning the import of all cotton products known to be produced in whole or in part in the Xinjiang Uyghur Autonomous Region of China, in line with WTO rules. While we primarily heard evidence on the cotton industry, we believe this ban should be extended to other industries."

- 19. In the light of their ongoing concerns in relation to these issues the Claimant wrote to the Second Defendant on 22nd April 2020 calling for action in relation to the presence of cotton from the XUAR in the value chain in the UK. A correspondence ensued over the course of the following 18 months, and for the purposes of this judgment it is unnecessary to focus in detail upon anything other than the final positions of the parties reached immediately prior to the court. It should, however, be noted that during the course of the correspondence the Claimant provided the Defendant with a large amount of evidence concerning the issues of forced labour and human rights abuses in the XUAR. This was, in essence, the evidence which has been provided to the court and which has been addressed above. The Defendant took account of and considered this material in reaching decisions as to any actions in response to it, and the Defendant's conclusions were informed by it.
- 20. The correspondence enabled the discussions between the parties to be distilled into two areas for the purpose of assessing whether the Defendant was acting lawfully in relation to this issue. The first area was the concern that the Defendant ought to have been actively investigating, and thereafter prohibiting the importation of, cotton goods with their origin in the XUAR using the powers available under section 1 of the 1897 Act and the associated power under section 139 of the Customs and Excise Management Act 1979. In relation to this issue the finally resolved position of the Defendant was set out in the letter from their solicitors dated 10th September 2021 as follows:

" 14. The Parliamentary intention underlying the introduction of FPMGA was to protect the UK market from being undermined by under-priced foreign imports. It was not enacted as a measure directed at safeguarding the welfare of prisoners. Rather the measure sought to strike a balance between the protection and promotion of international trade. Notably, the prohibition was not directed at prison-made goods *per se*. For instance, no prohibition was enacted by FPMGA in respect of prison-made goods not imported for the purposes of trade, or of a description not manufactured in the UK.

15. It is also necessary to note that the standard required by s.1 FPMGA to establish that the relevant goods are prison-made is high – *viz*. that it must be <u>proved</u> by evidence tendered to the satisfaction of the relevant enforcing officer, on the balance of probabilities, that it was in fact made in a foreign prison. This was no doubt a measure intended to guard against the obvious impediment that would otherwise be caused

to legitimate trade in similar goods. As a consequence of its evidential requirements, however, s.1 FPMGA has long-been recognized as having limited operational value.

•••

17. BF's approach to foreign prison-made goods is described in an internal subject area information note as follows:

"[BF] role: -

The importation of goods made in foreign prisons is prohibited under section 1 [FPMGA]. Border Force operates on a reactive basis in response to intelligence suggesting goods were made in a foreign prison. Prison made goods will be seized where they are detected and where reacting to intelligence. ... applicable exceptions [are] listed in the 1897 Act."

18. The reference to "*intelligence*" in this context would not be for BF to gather but refers to case specific intelligence originating from a legitimate source. In practice this is most likely to be intelligence provided by another agency or Government department.

19. Importantly, s. 1 FPMGA envisages the production of evidence linking a specific consignment of goods to a specified facility meeting the definition of a foreign prison. It is a necessary requirement to establish evidentially such a connection between the originating location and a particular shipment of goods. It follows that it is, in practice, implausible that a conclusion could be reached that s.1 FPMGA had been contravened based on the nature of goods alone in circumstances where such goods were produced elsewhere. This is to say nothing of the complex nature of modern international supply chains which frequently involve multiple stages, not necessarily evident from a customs manifest or other documentary evidence accompanying the goods being moved."

21. The second issue which became distilled as a result of the discussions in the correspondence was the Claimant's contention that the Defendant ought to be investigating under the 2002 Act, on the basis that cotton goods with their origin in the XUAR could be criminal property and trading in them criminal conduct. The contention engaged the need for action under Part 7 and Part 5 of the Act (which are set out in detail below) which the Defendant was failing to undertake. The final position of the Defendants was again set out in their solicitor's letter dated 10th September 2021, and whilst it did not specifically engage with Part 5 of the 2002 Act, it was clarified in subsequent correspondence that the response dealt with both Parts 7 and 5 of the Act. The letter stated as follows:

" 31. So far as concerns an alleged failure to investigate possible money laundering offences under POCA, the Letter Before Claim proceeds on a misapprehension. There is no proper basis for a POCA investigation. 32. For the purposes of POCA, offences contrary to s.1 of the Modern Slavery Act and/or s. 51 of the International Criminal Court Act 2001 are capable of constituting criminal conduct within the meaning of s.340 POCA. However:

(i) It is a requirement of s.340 POCA that any criminal conduct is clearly and specifically identified and that the resultant property is specifically identified. It is insufficient, for the purposes of POCA, to deal in hypothetical scenarios or presumptions. In the absence of identifying a specific consignment of goods that is the product of the relevant criminality, the requirements of s. 340 are not met and no POCA offence can arise: see $R \lor GH$ [2015] UKSC 24.

(ii) Whilst the Letter Before Claim raises both the offences contrary to ss.328 and 329 POCA, it is apparent that, in the context of a supply chain, s.329 is the apposite offence (namely the acquisition, use and possession of criminal property, as opposed to entering into an arrangement which facilitates money laundering). However, it is a defence under s.329(2)(c) for a person to acquire or have possession of criminal property for adequate consideration. That provision reflects the policy aim of POCA, that it is not the function of the regime to taint the bona fide purchaser for value. Rather it is to seek the recovery of the proceeds of crime in the hands of a criminal. To the extent that it may be possible (which is currently doubted) to identify any specific product as criminal property, and any particular person as engaging in criminal conduct, within the meaning of s.340, it would nevertheless be the case that if that product has been the subject of a transaction for adequate consideration, the relevant criminal property would be the proceeds of that transaction in the hands of the criminal as seller, and not the product in the hands of the purchaser."

22. For the purposes of the present application these passages set out the resolved position of the Defendant and formed the basis upon which the case was argued. In addition to the correspondence the Defendant provided witness evidence from Mr David Huke, who is the Assistant Director and Head of the Customs Operational Policy Team in Border Force. In his witness statement, amongst other matters, he addresses the source of the internal subject area information note which is referred to in the correspondence above. Mr Huke describes the document in which the information about the 1897 Act appears as an Operational Policy Subject Area Information Note. He produces the whole document and whilst most of the operational text is redacted the headings which this material covers are not. This demonstrates that the document provides information in relation to a wide range of subject areas from the trade in endangered species to the shipment of waste. Mr Huke describes the document as an "internal document...used by Border Force Customs Operational Policy as a point of reference concerning the extensive range of controls on goods at the border and provides officers with useful contact information".

23. He goes on to explain that there have been no seizures or detentions of goods based on the 1897 Act. He also sets out that in the months of October, November and December 2020 over 1,000,000 consignments of goods that were, or could be considered to be, cotton goods arrived in the UK, and that there is no reason to assume that these volumes were other than the normal pattern of trade.

The law

24. As set out above, each of the grounds of challenge in this case relate to a contention that the Defendant was guilty of a misdirection in law in relation to the conduct of investigation in respect of the Claimant's concerns. This is consistent with the relevant principles of the law in this area, which reflects the deference which the court must afford to the wide range of considerations that the Defendant has to have regard to when operating as an agency of law enforcement. These principles were considered in the case of *R*(*Bermingham and others*) *v Director of the Serious Fraud Office* [2007] QB 727; [2006] EWHC 200, in which the Divisional Court was being asked to order the Director of the Serious Fraud Office to undertake an investigation to determine whether the Claimants should be charged and tried in the UK for the offences for which they were wanted by the authorities in the USA. Dismissing the claim and giving the leading judgment in the Divisional Court, Laws LJ observed as follows:

"63. I entertain considerable reservation as to the propriety of the courts embarking at all on a challenge to the Director's decision framed in such terms as these. There is much authority to the effect that the jurisdiction to conduct a judicial review of a public authority's decision to launch or not to launch a prosecution, though it undoubtedly exists, is to be exercised sparingly. Where the decision is to prosecute, this admonition of restraint arises in part at least out of the imperative that criminal proceedings should not be the subject of satellite proceedings which have the effect of delaying the trial: *R v Director of Public* Prosecutions. exparte С [1995] 1 CAR 136. especially per Kennedy LJ at 141; R v Director of Public Prosecutions, ex parte Kebilene [2000] 2 AC 326. Where the decision is not to prosecute, there cannot I think be a different rule; in any event there will have been expert assessments of weight and balance which are so conspicuously within the professional judgment of the statutory decision-maker that there will very rarely be legal space for a reviewing court to interfere.

64. Here, of course, the decision sought to be reviewed is a decision not to *investigate*. The position as regards the judicial review jurisdiction is in my judgment *a fortiori* a decision whether to prosecute. The authority's (here, the Director's) discretion is even more open-ended. It will involve consideration of the manner in which available resources should be deployed and whether particular lines of inquiry should or should not be followed: *Hill v Chief Constable of West Yorkshire [1989] 1 AC 53 per* Lord Keith of Kinkel at 59 D–F, summarising *R v. Commissioner of Police for the Metropolis, Ex parte Blackburn [1968] 2 QB 118*. It is submitted for the Director that absent bad

faith or other exceptional circumstances a decision to investigate or not to investigate an allegation of crime is not subject to review. That is not quite right. It looks like an argument to limit the court's *jurisdiction* of judicial review; but the jurisdiction is as wide or as narrow as the court holds. The true proposition is that it will take a wholly exceptional case on its legal merits to justify a judicial review of a discretionary decision by the Director to investigate or not."

25. A further case in which this issue was considered was the case of R(Corner House Research) v Serious Fraud Office [2008] UKHL 60, in which Lord Bingham, in a speech with which the other members of the House of Lords agreed, stated as follows in relation to the role of the court in enquiring into the manner in which a law enforcement agency has exercised its powers:

"31. The reasons why the courts are very slow to interfere are well understood. They are, first, that the powers in question are entrusted to the officers identified, and to no one else. No other authority may exercise these powers or make the judgments on which such exercise must depend. Secondly, the courts have recognised (as it was described in the cited passage of *Matalulu*)

"the polycentric character of official decision-making in such matters including policy and public interest considerations which are not susceptible of judicial review because it is within neither the constitutional function nor the practical competence of the courts to assess their merits".

Thirdly, the powers are conferred in very broad and unprescriptive terms.

32. Of course, and this again is uncontroversial, the discretions conferred on the Director are not unfettered. He must seek to exercise his powers so as to promote the statutory purpose for which he is given them. He must direct himself correctly in law. He must act lawfully. He must do his best to exercise an objective judgment on the relevant material available to him. He must exercise his powers in good faith, uninfluenced by any ulterior motive, predilection or prejudice. In the present case, the claimants have not sought to impugn the Director's good faith and honesty in any way."

26. The Claimant's grounds are framed in the light of these authorities: the Claimant contends that the Defendants misdirected themselves in their approach to the exercise of their powers under the 1897 and the 2002 Act, and that this is evidenced in the description of how they envisaged these powers operating in the correspondence set out above. The Claimant's case is not put on a *Wednesbury* basis, and it is essentially

common ground that absent the errors of law contended for there would be no proper basis for interfering with the Defendant's exercise of discretion in this case: only in wholly exceptional cases could such an interference be justified for the reasons given in the authorities.

27. Turning to the first of the legal themes of the Claimant's case, section 1 of the 1897 Act provides as amended as follows:

"1. Prohibition of importation of foreign prison made goods.

The importation of the following goods is prohibited]; that is to say:

Goods proved to the satisfaction of the Commissioners of Customs and Excise by evidence tendered to them to have been made or produced wholly or in part in any foreign prison, goal, house of correction, or penitentiary, except goods in transit or not imported for the purposes of trade, or of a description not manufactured in the United Kingdom or originating or in free circulation in another member State."

- 28. The Customs and Excise Management Act 1979 contains complementary powers for the forfeiture and seizure of goods which have been imported contrary to any prohibitions or restrictions in force in respect of them. Section 49(1)(b) provides the power to make goods imported contrary to restrictions such as that created by section 1 of the 1897 Act liable to forfeiture. Section 139(1A) of the 1979 Act entitles a person authorised under section 139(1) who reasonably suspects that any thing may be liable to forfeiture under customs and excise Acts to seize or detain that thing as liable to forfeiture.
- 29. The Claimant contends that part of the misdirection of law for which the Defendant can be criticised is that they have unlawfully fettered their discretion in relation to the Border Force "Subject Area Information Note" which is quoted above. In this respect the Claimants rely upon the legal principles which were set out by Laws and Treacy LJ in their judgment in the case of *R(West Berkshire DC) v Secretary of State for Communities and Local Government* [2016] 1 WLR 3923; [2016] EWCA Civ 441 at paragraphs 16 to 18 as follows:

"16. ...It is important first to notice a distinction in this area of the law which is at the core of the debate in this appeal. It is between these two principles. (1) The exercise of public discretionary power requires the decision-maker to bring his mind to bear on every case; he cannot blindly follow a preexisting policywithout considering anything said to persuade him that the case is an exception. See *British Oxygen Co Ltd v Board of Trade* [1971] AC 610, in which Lord Reid and Viscount Dilhorne cited the classic authority of R v Port of London Authority, Ex p Kynoch Ltd [1919] 1 KB 176, 184 per Bankes LJ. 17. But (2): a policy-maker (notably central government) is entitled to express his policy in unqualified terms. He is not required to spell out the legal fact that the application of the policy must allow for the possibility of exceptions. As is stated in *De Smith's Judicial Review*, 7th ed (2013), para 9-013:

"a general rule of policy that does not on its fact admit of exception will be permitted in most circumstances. There may be a number of circumstances where the authority will want to emphasise its policy...but the proof of the fettering will be in the willingness to entertain exceptions to the policy, rather than in the words of the policy itself."

18. Both of these principles-the rule against fettering discretion, and the liberty (generally) to express policy without acknowledging exceptions-apply whether or not the policymaker and the decision-maker are the same or different persons. If it were otherwise, neither would have any integrity as a principle."

30. In the light of the way in which the Defendant responds to this point, there is an additional matter which needs to be addressed. The Defendant submits that the "Subject Area Information Note" is not a policy or a piece of guidance in relation to the exercise of the powers under section 1 of the 1897 Act, but no more than what it says, a note containing information. The question of what amounts to a policy was addressed in the decision of the Supreme Court in R(on the application of A) v Secretary of State for the Home Department [2021] UKSC 37 in which Lord Sales and Lord Burnett observed as follows:

"2. It is a familiar feature of public law that Ministers and other public authorities often have wide discretionary powers to exercise. Usually these are conferred by statute, but in the case of Ministers they may derive from the common law or prerogative powers of the Crown, which fall to be exercised by them or on their advice. Where public authorities have wide discretionary powers, they may find it helpful to promulgate policy documents to give guidance about how they may use those powers in practice. Policies may promote a number of objectives. In particular, where a number of officials all have to exercise the same discretionary powers in a stream of individual cases which come before them, a policy may provide them with guidance so that they apply the powers in similar ways and the risk of arbitrary or capricious differences of outcomes is reduced. If placed in the public domain, policies can help individuals to understand how discretionary powers are likely to be exercised in their situations and can provide standards against which public authorities can be held to account. In all these ways, policies can be an important tool in promoting good administration."

31. The second legal theme of the Claimant's grounds is reliance upon the powers contained within the 2002 Act. Central to those powers, and the offences which are in point derived from Part 7 of the 2002 Act, is the definition of criminal property which is contained within section 340 of that Act. These provisions provide as follows:

"340. Interpretation

- (1) This section applies for the purposes of this Part.
- (2) Criminal conduct is conduct which—

constitutes an offence in any part of the United Kingdom, or

would constitute an offence in any part of the United Kingdom if it occurred there.

(3) Property is criminal property if—

it constitutes a person's benefit from criminal conduct or it represents such a benefit (in whole or part and whether directly or indirectly), and

the alleged offender knows or suspects that it constitutes or represents such a benefit.

(4) It is immaterial—

who carried out the conduct;

who benefited from it;

(c) whether the conduct occurred before or after the passing of this Act.

(5) A person benefits from conduct if he obtains property as a result of or in connection with the conduct.

(6) If a person obtains a pecuniary advantage as a result of or in connection with conduct, he is to be taken to obtain as a result of or in connection with the conduct a sum of money equal to the value of the pecuniary advantage.

(7) References to property or a pecuniary advantage obtained in connection with conduct include references to property or a pecuniary advantage obtained in both that connection and some other.

(8) If a person benefits from conduct his benefit is the property obtained as a result of or in connection with the conduct.

...

(11) Money Laundering is an act which-

(a) constitutes an offence under section 327,328 or 329,

(b) constitutes an attempt, conspiracy or incitement to commit an offence specified in paragraph (a),

(c) constitutes aiding, abetting, counselling or procuring the commission of an offence specified in paragraph (a),

(d) would constitute an offence specified in paragraph (a), (b) or (c) if it were committed in the United Kingdom."

32. There is no question arising in relation to the definition of property for these purposes, as it is widely defined by section 340(9) of the 2002 Act. One of the key issues in the case depends upon the application of the definition of criminal property. The offences contained within the 2002 Act and which are relevant to the issues in this case are as follows. Firstly, under section 327 of the 2002 Act there is the offence of concealing criminal property. The pertinent provisions of section 327 are as follows:

"327 Concealing etc

- (1) A person commits an offence if he-
 - (a) conceals criminal property;
 - (b) disguises criminal property;
 - (c) converts criminal property;
 - (d) transfers criminal property;

(e) removes criminal property from England and Wales or from Scotland or from Northern Ireland.

(2) But a person does not commit such an offence if-

(a) he makes an authorised disclosure under <u>section 338</u> and (if the disclosure is made before he does the act mentioned in subsection (1)) he has the appropriate consent;

(b) he intended to make such a disclosure but had a reasonable excuse for not doing so;

(c) the act he does is done in carrying out a function he has relating to the enforcement of any provision of this Act or of any other enactment relating to criminal conduct or benefit from criminal conduct.

(2A) Nor does a person commit an offence under subsection (1) if-

(a) he knows, or believes on reasonable grounds, that the relevant criminal conduct occurred in a particular country or territory outside the United Kingdom, and

(b) the relevant criminal conduct—

(i) was not, at the time it occurred, unlawful under the criminal law then applying in that country or territory, and

(ii) is not of a description prescribed by an order made by the Secretary of State.

(2B) In subsection (2A) *"the relevant criminal conduct"* is the criminal conduct by reference to which the property concerned is criminal property.

(2C) A deposit-taking body, electronic money institution or payment institution that does an act mentioned in paragraph (c) or (d) of subsection (1) does not commit an offence under that subsection if—

(a) it does the act in operating an account maintained with it, and

(b) the value of the criminal property concerned is less than the threshold amount determined under <u>section 339A</u> for the act.

(3) Concealing or disguising criminal property includes concealing or disguising its nature, source, location, disposition, movement or ownership or any rights with respect to it."

33. Secondly, section 328 of the 2002 Act creates an offence of being involved in an arrangement in relation to criminal property. This offence is defined as follows:

"328 Arrangements

(1) A person commits an offence if he enters into or becomes concerned in an arrangement which he knows or suspects facilitates (by whatever means) the acquisition, retention, use or control of criminal property by or on behalf of another person.

(2) But a person does not commit such an offence if-

(a) he makes an authorised disclosure under <u>section 338</u> and (if the disclosure is made before he does the act mentioned in subsection (1)) he has the appropriate consent;

(b) he intended to make such a disclosure but had a reasonable excuse for not doing so;

(c) the act he does is done in carrying out a function he has relating to the enforcement of any provision of this Act or of any other enactment relating to criminal conduct or benefit from criminal conduct.

(3) Nor does a person commit an offence under subsection (1) if—

(a) he knows, or believes on reasonable grounds, that the relevant criminal conduct occurred in a particular country or territory outside the United Kingdom, and

(b) the relevant criminal conduct—

(i) was not, at the time it occurred, unlawful under the criminal law then applying in that country or territory, and

(ii) is not of a description prescribed by an order made by the Secretary of State.

(4) In subsection (3)"the relevant criminal conduct" is the criminal conduct by reference to which the property concerned is criminal property."

34. Thirdly, the 2002 Act creates an offence of acquisition, use and possession of criminal property. The terms of section 329 which creates this offence is as follows:

"329 Acquisition, use and possession

- (1) A person commits an offence if he-
- (a) acquires criminal property;
- (b) uses criminal property;
- (c) has possession of criminal property.
- (2) But a person does not commit such an offence if—

(a) he makes an authorised disclosure under section 338 and (if the disclosure is made before he does the act mentioned in subsection (1)) he has the appropriate consent;

(b) he intended to make such a disclosure but had a reasonable excuse for not doing so;

(c) he acquired or used or had possession of the property for adequate consideration;

(d) the act he does is done in carrying out a function he has relating to the enforcement of any provision of this Act or of any other enactment relating to criminal conduct or benefit from criminal conduct.

(2A) Nor does a person commit an offence under subsection (1) if—

(a) he knows, or believes on reasonable grounds, that the relevant criminal conduct occurred in a particular country or territory outside the United Kingdom, and

(b) the relevant criminal conduct—

(i) was not, at the time it occurred, unlawful under the criminal law then applying in that country or territory, and

(ii) is not of a description prescribed by an order made by the Secretary of State.

(2B) In subsection (2A) "the relevant criminal conduct" is the criminal conduct by reference to which the property concerned is criminal property.]

(2C) A deposit-taking body, electronic money institution or payment institution that does an act mentioned in subsection (1) does not commit an offence under that subsection if—

(a) it does the act in operating an account maintained with it, and

(b) the value of the criminal property concerned is less than the threshold amount determined under section 339A for the act.

(3) For the purposes of this section—

(a) a person acquires property for inadequate consideration if the value of the consideration is significantly less than the value of the property;

(b) a person uses or has possession of property for inadequate consideration if the value of the consideration is significantly less than the value of the use or possession;

(c) the provision by a person of goods or services which he knows or suspects may help another to carry out criminal conduct is not consideration."

35. The question of proving that particular property is criminal property for the purposes of these offences has been considered by the courts on several occasions. In the case of R v Montila [2004] 1 WLR 3141; [2004] UKHL 50 a number of defendants were charged with offences of concealing, disguising, converting or transferring property knowing or having reason to suspect that the property represented another person's proceeds of criminal conduct or drug trafficking. A preliminary question arose as to whether it was necessary for the prosecution to prove that the property which was the

subject of the charge was in fact the proceeds of crime. The House of Lords ruled that it was necessary to prove that the property was the proceeds of crime, and that the property had its origins in criminal conduct, as an essential part of the actus reus of the offence. Although the particular charges which the defendants faced were not framed under the 2002 Act, Lord Hope, giving the opinion of the Committee, addressed the language of section 340 of the 2002 Act as well as the international legal instruments which provided the background to the creation of the legislation. Lord Hope concluded that the expression "criminal property" required the prosecutor to prove that the property was the proceeds of crime and had its origins in criminal conduct (see paragraph 41).

36. The Claimant also draws attention in relation to these issues to the decision of the Court of Appeal in the case of *R v Anwoir and others* [2009] 1 WLR 980; [2008] EWCA Crim 1354. In that case the defendants were charged under section 328 of the 2002 Act, and the question arose as to what the prosecution needed to prove to establish that the property in question was criminal property within the meaning of section 340 of the 2002 Act. In giving the judgment of the Court of Appeal Latham LJ stated as follows at paragraph 21:

"We consider that in the present case the Crown are correct in their submission that there are two ways in which the Crown can prove the property derives from crime, (a) by showing that it derives from conduct of a specific kind or kinds and that conduct of that kind or those kinds is unlawful, or (b) by evidence of the circumstances in which the property is handled which are such as to give rise to the irresistible inference that it can only be derived from crime."

- 37. It is to be noted from Latham LJ's formulation of the requirements that, firstly, there is no need to identify the specific offence which is relied upon to demonstrate that the property is criminal property. Further, Latham LJ referred specifically to circumstantial evidence as being material which could be relied upon if it gives rise to an "irresistible inference" that the property could only be derived from crime.
- 38. These issues were addressed by the Supreme Court in the case of R v GH [2015] 1 WLR 2126; [2015] UKSC 24. The case concerned an arrangement struck between the defendant and a fraudster whereby the defendant opened two bank accounts and then gave the associated bank cards and documentation to the fraudster, who then used them to establish fraudulent car insurance websites. The defendant was charged with entering into or being concerned in a money laundering arrangement contrary to section 328(1) of the 2002 Act. The case was stopped by the judge at the close of the evidence on the basis that at the time that the arrangement had been entered into there had not been any criminal property in existence.
- 39. In giving the judgment of the Supreme Court, with which all other members of the court agreed, Lord Toulson observed, at paragraph 20, that there was an unbroken line of Court of Appeal authority holding that it is a prerequisite of the offences created by sections 327, 328 and 329 of the 2002 Act that property alleged to be criminal property should have that quality or status at the time of the alleged offence. In other words, criminal property means property obtained as a result of, or in connection with, criminal activity separate from that which is the subject of the charge itself. On this basis Lord

Toulson rejected the prosecution submission that the same conduct could both cause property to become criminal and also simultaneously constitute the offence under section 328 of the 2002 Act. Lord Toulson did, however, accept that it did not matter whether the criminal property existed at the time of entering into the arrangement to deal with it was made: what mattered was that the property was criminal at the time when the arrangement operated upon it. In the case being considered what rendered the property criminal property was not the arrangement between the defendant and the fraudster, but rather that the property was obtained by the fraudster by the operation of deception upon the victims. Thus it could be legitimately concluded that the defendant had participated in an arrangement to retain criminal property for the benefit of another and the judge had been wrong to withdraw the case from the jury.

40. As set out above, there are further provisions in Part 5 of the 2002 Act which create powers for the civil recovery of the proceeds of crime. Section 240 of the 2002 Act sets out that the purpose of Part 5 is to enable the recovery in civil proceedings of property which is, or which represents, property obtained through unlawful conduct, as well as enabling such property to be forfeited in civil proceedings. Section 241 defines unlawful conduct in the following terms:

"241 "Unlawful conduct"

(1) Conduct occurring in any part of the United Kingdom is unlawful conduct if it is unlawful under the criminal law of that part.

(2) Conduct which—

(a) occurs in a country [or territory]1 outside the United Kingdom and is unlawful under the criminal law [applying in that country or territory], and(b) if it occurred in a part of the United Kingdom, would be unlawful under the criminal law of that part,

is also unlawful conduct.

- (2A) Conduct which-
 - (a) occurs in a country or territory outside the United Kingdom,

(b) constitutes, or is connected with, the commission of a gross human rights abuse or violation (see section 241A), and

(c) if it occurred in a part of the United Kingdom, would be an offence triable under the criminal law of that part on indictment only or either on indictment or summarily,

is also unlawful conduct.

(3) The court or sheriff must decide on a balance of probabilities whether it is proved—

- (a) that any matters alleged to constitute unlawful conduct have occurred, or
- (b) that any person intended to use any property in unlawful conduct.

41. Section 241A provides further definition in relation to what amounts to "gross human rights abuse or violation" so as to give the provisions extra-territorial effect. Thereafter section 242 provides as follows in relation to obtaining property through unlawful conduct:

"242 "Property obtained through unlawful conduct"

(1) A person obtains property through unlawful conduct (whether his own conduct or another's) if he obtains property by or in return for the conduct.

(2) In deciding whether any property was obtained through unlawful conduct—

(a) it is immaterial whether or not any money, goods or services were provided in order to put the person in question in a position to carry out the conduct,

(b) it is not necessary to show that the conduct was of a particular kind if it is shown that the property was obtained through conduct of one of a number of kinds, each of which would have been unlawful conduct."

42. Consequent upon these provisions section 304 of the 2002 Act provides that property which has been obtained through unlawful conduct is recoverable property, and further that recoverable property obtained by unlawful conduct may be followed into the hands of a person obtaining it on a disposal either by the person who through the conduct obtained the property or a person into whose hands it may, as a result of these provisions be followed. Section 305 and 306 further develop these principles as follows:

"305 Tracing Property, etc

(1) Where property obtained through unlawful conduct ("the original property") is or has been recoverable, property which represents the original property is also recoverable property.

(2) If a person enters into a transaction by which-

(a) He disposes of recoverable property, whether the original property or property which (by virtue of this Chapter) represents the original property, and

(b) He obtains other property in place of it,

The other property represents the original property.

(3) If a person disposes of receoverable property which represents the original property, the property may be followed into the hands of the person who obtains it (and it continues to represent the original property).

306 Mixing property

- (1) Subsection (2) applies if a person's recoverable property is mixed with other property (whether his property or another's).
- (2) The portion of the mixed property which is attributable to the recoverable property represents the property obtained through unlawful conduct.
- (3) Recoverable property is mixed with other property if (for example) it is used-
 - (a) To increase funds held in a bank account,
 - (b) In part payment for the acquisition of an asset,
 - (c) For the restoration or improvement of land,
 - (ca) for the discharge (in whole or in part) of a mortgage, charge or other security,
 - (d) By a person holding a leasehold interest in the property to acquire the freehold."
- 43. It is against the background of these legal provisions that the Claimant's submissions that the stated position of the Defendant betrays mis-directions of law fall to be evaluated.

Submissions and conclusions

- 44. In addressing Ground 1 it is worthwhile returning to the Defendant's impugned approach which was set out in the correspondence rehearsed above. The Defendant noted that "the standard required by s1 FPMGA to establish that the relevant goods are prison-made is high viz that it must be <u>proved</u> by evidence tendered to the satisfaction of the relevant enforcing officer, on the balance of probabilities, that it was in fact made in a foreign prison". Furthermore, the Defendant, in paragraph 19 of the letter dated 10th September 2021 to the Claimant, states that "s1 FPMGA envisages the production of evidence linking a specific consignment of goods to a specified facility meeting the definition of a foreign prison", and that it needed to be established "evidentially that such a connection between the originating location and a particular shipment of goods" could be proved. In practice it would be implausible such a conclusion could be reached on the basis of the nature of the goods alone in circumstances where such goods were produced elsewhere. This was prior to giving consideration to the complexities of modern international supply chains.
- 45. The Claimant contends that this approach contains a misdirection of law. Firstly, it is submitted that the statute does not limit the type of evidence which could be taken into account, and therefore circumstantial evidence could be relied upon to meet the balance of probabilities threshold. Secondly, it is submitted that the Defendant is in effect imposing a higher threshold in practice than the balance of probabilities: by requiring that there be proof that there be evidence linking a specific consignment of goods to a particular foreign prison the Defendant was in reality seeking proof that they were

definitely produced there, or at the very least that it was highly likely that they were produced there. This was not an approach to the test which was warranted by a proper construction of section 1 of the 1987 Act. All that was required was for the enforcement officer to be satisfied that the goods in question were more likely than not to have been made in a foreign prison, and that is a question which could be satisfied on the basis of the available circumstantial evidence.

- 46. Although points were made by the Defendant in the correspondence relying upon various extracts from Hansard, both contemporaneous with the legislation and subsequently, little was made of this material in the course of argument. In my view this was sensible and little further needs to be said on this topic. There were two central themes to the submissions of the Defendant in response to the Claimant's argument. The first point is concerned with the proper construction of section 1 of the 1897 Act; the second point is concerned with the practical evidential difficulties with the Claimant's case.
- 47. The Defendant's submissions in relation to the correct interpretation of section 1 of the 1897 Act start with the contention that the words of the prohibition contained in the section require that the link is proved between the goods being assessed by the enforcement officer and their manufacture in a foreign prison. The provisions of the section are said to be clear in requiring proof in respect of the actual consignment under consideration: if there is evidence to support the contention that the goods were not produced in a foreign prison (bearing in mind the distinction between prison labour, or detained labour, as distinct from forced labour, a distinction which the Claimant accepts) then the goods will be excluded from the prohibition.
- 48. Secondly, the Defendant contends that the section requires proof of an unbroken chain between the goods and their manufacture in a foreign prison. It is accepted that assessment can include circumstantial evidence, but there still needs to be a sufficiency of evidence to prove the link. Thirdly, the Defendant submits that the statistical approach taken by the Claimant on the basis of the available circumstantial evidence does not amount to proof of the prohibition. If the statistical approach is taken, and the question is analysed on the basis of, for example, an assumption that the majority of consignments are made in a foreign prison, then that approach lumps together both prohibited and untainted consignments in a manner which does not enable the question posed by the section to be answered with integrity. In a similar way, the Claimant's approach to the balance of probabilities confuses the chance of an event occurring with the event itself, and is also flawed in a similar fashion to the statistical approach.
- 49. Fourthly, the effect of the Claimant's submissions is to substitute a requirement that a high proportion of the consignments presented to the enforcement officer were made in a foreign prison for the correct requirement that the link is established between the specific consignment being considered and its manufacture in a foreign prison. On this basis forfeiture could readily occur in relation to consignments which were not tainted, leading to the serious consequence of legitimate importers being deprived of goods by confiscation.
- 50. The Defendant's submissions in relation to the evidential difficulties presented by the Claimant's approach relate to both this Ground and also Grounds 3 and 4. The Defendant points out that whilst the evidence which the Claimant has produced goes to the question of whether there is credible evidence of human rights abuses in the cotton

industry in XUAR generally, that material is insufficient to enable conclusions to be drawn as to the particular or specific circumstances of an individual consignment of goods. This is not a question of circumstantial evidence: whilst circumstantial evidence of the existence of a fact may be compelling that is a different from circumstantial evidence of the chance of a fact existing.

- 51. Furthermore the evidence submitted by the Claimant leaves many important questions unanswered. For instance, what percentage of the cotton sourced from XUAR is manufactured by prison or detained labour and what percentage is in fact from forced labour and therefore not within the scope of section 1 of the 1897 Act. There are further uncertainties in relation to the percentages of the cotton concerned which has come directly or indirectly from China, and the evidence does not warrant the conclusion that the vast majority of the cotton consignments are manufactured by detained or prison labour.
- 52. There are further problems in the evidence. For instance, in relation to the implicated company LuThai, the Claimant submits that it is reasonable "to infer that the manufacturing of fabric and cotton products in Shandong makes use of significant amount of cotton materials which were initially produced in LuThai's XUAR facilities" notwithstanding LuThai having sold its stake in its XUAR subsidiary in 2020. Thus the Defendant submits that the Claimant must be contending that the sale of the subsidiary was a sham, further adding to the lack of clarity in the evidential basis for the Claimant's case. The Claimant is unable to point to any specific instance of criminality, and the circumstantial evidence of statistical risks of criminality is not a substitute for proof.
- 53. Ultimately in connection with the evidential difficulties the Defendant contends that the reality of the Claimant's case is that they are seeking to apply a reverse burden of proof to the situation. That is unwarranted and in particular is not justified by the correct approach to section 1 of the 1897 Act.
- 54. Central to the resolution of the issues raised under Ground 1 is, in my judgment, the question of the correct approach to the construction of section 1 of the 1897 Act and whether that is reflected in the stated position of the Defendant in the letter of 10th September 2021. In my view, the terms of the definition of the goods that are prohibited from importation by section 1 of the 1897 Act are clear and straightforward. Firstly, and uncontroversially, the burden of proof that the goods are prohibited rests with the enforcement officer; the standard of proof is the balance of probabilities. Secondly, it is clear that the question for the enforcement officer relates specifically to the goods that are being examined and that it needs to be proved on the balance of probabilities that those goods were made or produced wholly or in part in a foreign prison. It was accepted by the Defendant in the course of argument that it would not be necessary to prove the specific prison in which the goods were manufactured, and this was a sensible concession. However, the link between a specific consignment of goods and their manufacture in a foreign prison still needs to be proved for the prohibition under section 1 of the 1897 Act to be made out.
- 55. This construction of section 1 of the 1897 Act is entirely consistent with the approach outlined in the Defendant's letter dated 10th September 2021. I am unable to accept the Claimant's contention that this approach in any way limits the types of evidence to be received and evaluated as part of the application of section 1. As was accepted by the Defendant in the course of argument, circumstantial evidence can be brought into

account: the real question is whether on the basis of all the available evidence the prohibition is proved. I am also unable to accept that by requiring evidence linking the specific consignment under consideration to manufacture by detained or prison labour a higher standard of proof than the balance of probabilities is being applied. The requirement for evidence linking the consignment being examined to such manufacture faithfully reflects the requirements of section 1 of the 1897 Act. I have reached the conclusion that the Defendant's approach is legally sound and not subject to any misdirection. This is sufficient to dispose of the Claimant's Ground 1.

- 56. The arguments which ranged beyond this position appear to examine the appropriateness of the Defendant's evaluation of the available evidence in circumstances where the Claimant has, correctly, been clear that this is not a challenge based on Wednesbury principles in relation to the failure of the Defendant to further investigate consignments of cotton hitherto. In any event, I am satisfied that there is some substance in the misgivings expressed by the Defendant as to the Claimant's approach to proof of the prohibition under section 1. It is undoubted that there is clear and undisputed evidence of instances of cotton being manufactured in the XUAR by the use of detained and prison labour as well as by forced labour in the facilities which have been described above. However, this does not in and of itself satisfy the proof required by section 1 of the 1897 Act for the reasons given by the Defendant. The relative proportions of goods derived from detained or prison labour is not ascertainable in detail, nor are the proportions of good derived from forced labour. Moreover, as the Defendant submits, it is not appropriate to equate proof of a fact (in this case the manufacture of a specific consignment of goods by prison or detained labour) on the balance of probabilities with the chance or risk that this may be the case. Substituting an assessment of the chance or risk of the goods being tainted for an examination of whether on the balance of probabilities the particular goods were tainted carries with it the obvious potential for not properly distinguishing between goods which are actually in fact tainted from those which in fact are not, leading to the forfeiture of goods not properly the subject of the prohibition. This further reinforces the robustness of the Defendant's analysis of these issues.
- 57. I turn to the questions raised under the Claimant's Ground 2. This is the contention that the Border Force note set out above unlawfully fettered the Defendant's discretion to investigate breaches of section 1 of the 1897 Act. As set out above in the correspondence, the text of the document which the Claimant relies upon is as follows:

"The importation of goods made in foreign prisons is prohibited under section 1 of The Foreign Prison Made Goods Act 1897. Border Force operates on a reactive basis in response to intelligence suggesting goods were made in a foreign prison. Prison made goods will be seized where they are detected and where reacting to intelligence."

58. The Claimant contends, firstly, that this is a policy document since it provides guidance as to how the discretionary powers under the 1897 Act are to be exercised. As such, therefore, applying the principles set out in the case of *A* above, it is clear that the document does have the status of policy for public law purposes. The Claimant's second submission is that the terms of the policy unlawfully fetter the discretion under section 1 of the 1897 Act in that it has the effect of precluding an officer of Border Force investigating any potential breach proactively, since the officer is directed by the policy to operate solely on a reactive basis and by reacting to intelligence. Even if an investigation were merited by the circumstances of the case this would be precluded by the terms of the policy.

- 59. By contrast, the Defendant submits that the document referred to is not a policy. It is submitted that it is in truth what it describes itself as, and what it is described as by Mr Huke, namely a note containing information (including contact data) to act as an aide memoir for officers in their role rather than instruct or guide them in how to undertake their duties. Furthermore, in describing Border Force operating on a reactive basis it is faithfully reflecting both the legislative provisions of the 1897 Act and also the role that Border Force plays in practice. The provisions of section 1 refer to the operation of the section depending upon "evidence tendered to" the enforcement officer satisfying the officer that the goods in question were manufactured in a foreign prison: the provision therefore describes a process of reacting to evidence provided to the officer. Border Force in practice carry out their role by responding to intelligence provided to them in the import or export process by other Government departments or law enforcement agencies. Far from being a policy the document is contended to simply amount to a note containing information about the 1897 Act.
- 60. The Defendant goes on to contend that, even were the document to be considered in law to be a policy, it does not give rise to an unlawful fettering of the discretion of the enforcement officer in exercising the powers under section 1 of the 1897 Act. As set out in the first submission, the Defendant contends that the text simply reflects of the provisions of section 1, which do not prohibit the importation of goods or their seizure on the basis of reasonable suspicion. Guidance which suggested that were possible would, therefore, be unlawful. On the other hand, the text of the document does not in any way suggest that the Border Force officer is not entitled to exercise the investigatory powers available under the Customs and Excise Management Act 1979 where appropriate.
- 61. Having considered these submissions I am not satisfied that the Claimant is correct to characterise the document in question in this part of the case as a policy. It appears clear to me, both from the terms of the document and such contextual material as is available to the court, to be simply an information note designed as nothing more than an aide memoire for Border Force staff. I have reached that conclusion for the following reasons.
- 62. Firstly, that is the way in which the document describes itself: it is headed, prior to the headings in relation to the subject areas, "Subject area information", and there is no indication that it is intended to operate as a policy in relation to the conduct of duties under those subject areas. Secondly, it is clear that the text itself is essentially descriptive rather than prescriptive in relation to the operations of Border Force in this area. Whilst most of the document was no doubt redacted for good reason, and it would have been helpful for context to see how the other areas under the headings were treated, judging simply on the basis of the text set out above and also the text in the document related to the Proceeds of Crime Act 2002, I am satisfied that this is an information sheet and not an operational policy.
- 63. Thirdly, I have no reason to go behind the evidence of Mr Huke in which he explains, as set out above, that the document is "a point of reference concerning the extensive range of controls on goods at the border and provides officers with helpful contact

information". This is inconsistent with the document containing a policy on the exercise of the powers under section 1 of the 1897 Act. For these reasons I am satisfied that the document is not a policy in the legal sense set out in *A*, and that is sufficient to dispose of the Claimant's case under Ground 2.

64. Notwithstanding this conclusion, in my view there would be no substance in Ground 2 even were it to be concluded that the document did contain policy on the exercise of the power under section 1 of the 1897 Act, since I am not convinced that even were it to be considered policy that it represents an unlawful fettering of the Border Force officer's discretion. Firstly, applying the principles set out in the *West Berkshire* set out above, the fact that the policy does not specifically admit of exceptions does not mean the possibility that there may be exceptions does not exist. This possibility does not have to be spelled out for the policy to be lawful. Secondly, as pointed out by the Defendant and noted above, the language of the document does faithfully reflect the terms of section 1 of the 1897 Act and the way in which Border Force operates in practice. As described in the evidence of Mr Huke, the way in which Border Force selects consignments is as follows:

"13. Border Force may select goods to examine using information gathered from a range of sources. For example, Border Force may use historical data (of successful examinations and seizures); concerns identified through an analysis of the declaration (or manifest); and/or information provided by other Government departments and law enforcement agencies (that could be of a general or specific nature)."

- 65. Thirdly, and related to the first point of principle which is set out above, the terms of the document do not suggest that if appropriate the enforcement officer is not permitted to exercise powers provided by the 1979 Act for the purposes of investigaton, such as for instance the power pursuant to section 139(1A) of that Act to detain any thing which the officer "reasonably suspects...may be liable to forfeiture". Taking these points together it appears to me that even if the document were taken to amount to a policy, rather than fettering the discretion of the enforcement officer it provides a succinct and coherent explanation of how the power under section 1 of the 1897 Act is exercised.
- 66. In conclusion, I am not satisfied that any of the concerns of the Claimant in relation to Ground 2 are made out. It follows that I am unable to uphold either of their complaints which are related to the Defendant's approach to section 1 of the 1897 Act.
- 67. Ground 3 relates to the Claimant's contention that the Defendant's approach to the use of the powers available under Part 7 of the 2002 Act has been driven by a misdirection of law. The submissions under Ground 4, in relation to the failure to deploy the powers of civil recovery under Part 5 of the 2002 Act, are related to this contention, in that again the Claimant contends that the approach of the Defendant is misconceived as a matter of law. As set out above, in the correspondence the Defendant essentially relies upon the same submissions in relation to both Grounds 3 and 4, and asserts that there is no proper basis in the Claimant's material for an investigation under the 2002 Act.
- 68. Whilst the Defendant accepts that for the purposes of the 2002 Act the offences of forced labour contrary to section 1 of the Modern Slavery Act 2015 and crimes against humanity contrary to section 51(1) of the International Criminal Court Act 2001 are

capable of constituting criminal conduct within section 340 of the 2002 Act, they submit that further evidence would be required in order for the provisions of the 2002 Act to be engaged. The essence of the Defendant's approach is to be found in the correspondence at paragraph 32(i) set out above where it is noted:

"(i) It is a requirement of s.340 POCA that any criminal conduct is clearly and specifically identified and that the resultant property is specifically identified. It is insufficient, for the purposes of POCA, to deal in hypothetical scenarios or presumptions. In the absence of identifying a specific consignment of goods that is the product of the relevant criminality, the requirements of s. 340 are not met and no POCA offence can arise: see $R \lor GH$ [2015] UKSC 24."

- 69. In respect of the specific offence under section 329 of the 2002 Act, which the Defendant considers the most apposite offence in relation to a supply chain, as it relates to the acquisition, use and possession of criminal property, the Defendant notes that under section 329(2)(c) it is a defence for a person to acquire or have possession of criminal property for an adequate consideration. This is considered by the Defendant to be a further impediment to the use of the powers under the 2002 Act, although it is conceded that the offences under section 327 and 328 of the Act are also potentially to be considered.
- 70. The Claimant takes issue at the outset with the approach taken by the Defendant to the identification of the criminal property and, in particular, the need for a specific consignment to be identified. Against the background of the undisputed evidence of the widespread use of forced labour in the XUAR to produce cotton products, amounting to criminal conduct, then it should be agreed that the proceeds of the sale of such cotton products are capable of meeting the definition of criminal property in section 340 of the 2002 Act. The Defendant's insistence on proof in relation to a specific consignment of cotton does not necessarily reflect the emphasis in the authorities on the width of the definition of criminal property, which for instance does not require the proof of a specific crime or specific criminal conduct. Furthermore, even were a specific consignment to be required in order to satisfy the definition of criminal property, that could not properly be a requirement before commencing an investigation in relation to money laundering. The Claimant contends that the provisions of section 340 are well suited to an investigation of value chains where the goods involved are produced by criminal activity. The approach of the Defendant would imply that, for instance, in a fraud case it would be necessary for a complainant to provide full details of a bank account before the authorities could contemplate any investigation of the source of the funds within it.
- 71. In so far as the Defendant relies upon the provisions in section 329(2)(c) and the exemption from the offence of those who purchased for adequate consideration, the Claimant submits that this phrase is not clear and unambiguous in the way suggested by the Defendant. It needs to be understood in context, and here the context includes other provisions of the 2002 Act, including section 329(3) and its approach to inadequate consideration, as well as the international instruments relating to possession of criminal property. A sweeping construction of this provision could lead to the endorsement of a market in goods produced by modern slavery.

- 72. Turning to the provisions of Part 5 of the 2002 Act, and the powers of civil recovery, the Claimant draws attention to the fact that the standard of proof in relation to these powers is the balance of probabilities and therefore lower than that pertaining to Part 7. Furthermore, the Claimant submits that it is significant that the Criminal Finances Act 2017 introduced section 241A of the 2002 Act, which specifically expanded the definition of unlawful conduct so as to include gross human rights abuses or violations, further reinforcing the potential for the use of these powers in connection with international value chains linked to modern slavery of the kind with which this case is concerned.
- 73. In response the Defendant focusses on the centrality to all of the offences created by sections 327, 328 and 329 of the 2002 Act of the need to demonstrate the involvement of criminal property. The definition of criminal property requires proof that the property concerned constituted or represented a person's benefit from criminal conduct (as defined) and also that the alleged offender knew or suspected that the property constituted such a benefit. The importance of the required connection between the criminal conduct and the property is reinforced by the provisions of sections 340(4)(5) and (8) of the 2002 Act. The key submission made by the Defendant is that the legislative scheme does not engage with a case where there is alleged or suspected offending on one hand, and property on the other, but it is not possible to establish the connection between them. Instead the provisions of the 2002 Act require that there is specific property which can be identified as having been involved or connected with the kind of criminal conduct concerned in the case.
- 74. The Defendant draws attention to the specific requirements of the individual offences, commencing with that created by section 327 of the 2002 Act. This offence has at its heart certain specified types of treatment of criminal property in that the establishment of the involvement of criminal property is a central requirement for proving the commission of the offence. Turning to section 328 of the 2002 Act the offence has, in effect, a requirement for the proof of a double mens rea: firstly, the mental element involved in proving that the property concerned is criminal property, and, secondly, proving that the person accused knew or suspected that they were facilitating the acquisition, retention, use or control of the criminal property.
- 75. The provisions of section 329 introduce the additional complexity of the exemption in relation to the acquisition, use or possession of the property for adequate consideration. The Defendant points out that in relation to the importation of goods, where the importer is paying market value for the purchased goods they would not be tainted as a result of the operation of the provision. This approach is supported by the terms of section 329(3)(a) of the 2002 Act which provide that consideration which is "significantly less than the value of the property" would amount to inadequate consideration. As a result of these provisions, if a purchaser has bought a consignment of cotton goods from China bona fide and at a market value any taint passes to the purchase price and the criminal property remains in China. The Defendant points out that at any point in such a market supply chain stretching many thousands of miles the chain could be broken by the use of adequate consideration in any of the transactions involved.
- 76. The Defendant draws attention to the existence of authority in relation to the proper interpretation of the phrase adequate consideration in the context of section 329(2)(c). The case of *Hogan v DPP* [2007] 1 WLR 2944; [2007] EWHC 978 (Admin) concerned

a defendant who was found in possession of scaffolding which belonged to his former employer which he had paid £1,100 to acquire. He contended that he had purchased the scaffolding for adequate consideration. The Magistrate decided that he was entitled to take the whole of the circumstances of the case, including the fact that the accused knew that the scaffolding constituted a benefit from criminal conduct, into account when deciding whether consideration had been adequate. The Divisional Court held that the Magistrate had misdirected himself and that the question of whether consideration was adequate was an objective one, quite discrete and separate from the question of the accused knowing or suspecting that the property constituted a benefit from criminal conduct.

77. In giving the leading judgment of the Divisional Court, Irwin J provided as follows:

"16. ...Wherever the burden lies and whatever may be the consequential standard of proof, if criminal property is acquired for "adequate consideration", then no offence is committed under the Act. I emphasise that this requirement applies to *criminal* property. In other words, if the court concludes that adequate consideration has been given for the acquisition of property, then no offence is made out under the 2002 Act, even if the defendant who has acquired the property knows that it was stolen. I pause to observe that, in circumstances like that, other offences may well be made out, but they will not be offences under this part of the 2002 Act. I reach this conclusion as a matter of straightforward statutory interpretation.

17. What is the meaning of "adequate consideration"? This must be a question of fact in each case. In deciding it, my view is that a court is entitled-indeed has an obligation-to look at all relevant circumstances drawn from the evidence. But the question is an objective one. It is a discrete question from the question of knowledge, belief or suspicion by the defendant as to whether the property constitutes a benefit from criminal conduct. Thus, the question is not whether all relevant circumstances may be brought to bear on the adequacy of consideration. They may. The point is that this is a separate question from the state of mind of the defendant. It is an inevitable consequence of the way the 2002 Act is drawn that a person who acquires criminal property which he knows to be stolen, but acquires it for full consideration, will not be guilty under this part of the 2002 Act."

78. The Defendant's submission is that in relation to each of the offences under Part 7 of the 2002 Act it is clear that there is a requirement for specificity in relation to the particular consignment of goods in question, and a requirement to demonstrate that it is criminal property through proof that the particular consignment is derived from criminal conduct. An inference or a suspicion that it may be derived from criminal conduct is not enough. There are additional complexities presented in relation to the requirement for a double mens rea in respect of the offence under section 328, as well as the exemption in respect of adequate consideration under the offence created by section 329 of the 2002 Act. So far as either a criminal or a civil investigation is concerned the Defendant contends that there is little point in commencing

investigations which do not have a realistic prospect of any successful conclusion. The Defendant draws attention to the inevitable need for co-operation from the PRC authorities which, on the available material, will not be forthcoming, and the danger of embarking upon investigations which in addition to being incapable of effective resolution would also carry the risk of allegations of high-handed conduct and abuse of power.

- 79. The starting point for determining conclusions in respect of these rival submissions is the position expressed by the Defendant in correspondence, and the question of whether that position incorporated any error of law or misdirection which would entitle the Claimant to the grant of relief. The Defendant's position on the concerns raised related to the powers under the 2002 Act are set out above in paragraphs 32(i) and (ii) of the letter of the 10th September 2021. Paragraph 32(i) the Defendant records its central point that "[I]t is a requirement of s340 POCA that any criminal conduct is clearly and specifically identified and that the resultant property is specifically identified". In paragraph 32(ii) sets out the Defendant's points in relation to the exemption in relation to purchase for adequate consideration, and the importance of this issue in cases dealing with value chains. The Defendant's submissions which are recorded above are grounded in the position set out in the correspondence. Does this approach amount to a misdirection of law?
- 80. Having reflected on the respective position of the parties I am not satisfied that there is any legal error or misdirection in the approach taken by the Defendant to the provisions of the 2002 Act. Commencing with the provisions contained in Part 7 of the 2002 Act, in my view it is important to note they relate to the creation of criminal offences, which would need to be proved to the criminal standard. The Defendant is correct to point out that in relation to each of the offences the starting point must be the identification of criminal property applying the definition set out in section 340 of the 2002 Act. The requirements of section 340(3) are precise, and in order to prove that a consignment is criminal property it would be necessary to prove not only that "it constitutes a person's benefit from criminal conduct" but also that "the alleged offender knows or suspects that it constitutes or represents such a benefit". It is clear that in order for an offence to be made out under any of section 327, 328 or 329 these elements must be specifically proved in relation to specific property. Whilst the Claimant is entitled to draw attention to the extensive volume of material which evidences the significant concerns in relation to the use of prison and forced labour in the production of cotton in the XUAR, as the Defendant points out, specific proof rather than suspicion is required to make out the offences under Part 7 of the 2002 Act. The requirements which the Defendant stipulates for establishing the offences under this part of the 2002 Act are, in my view, orthodox, accurate and justify the approach that they have taken to the material provided to them by the Claimant.
- 81. In essence, the evidential difficulties which have been identified above in relation to Ground 1 are also pertinent to the issues arising under Grounds 3 and 4. The requirements based on authorities such as *Montila* and *GH* for criminal property to be established as a prerequisite of money laundering offences, by way of criminal conduct separate from the money laundering offence itself, means specific proof in relation to particular consignments cannot be necessarily inferred from the nature of the available evidence. As the Defendant points out, the necessary significant detail is not present addressing such issues as where precisely the criminal conduct occurred in relation to

the consignment being examined. Whilst the specific offence would not be required at the least the kind of criminal activity would need to be known. The details of when and by whom the conduct was committed would also no doubt be useful information. The available evidence is unable to fulfil these requirements or provide these details in respect of a specific consignment and the concerns of the Defendant in connection with them are justified.

- 82. Whilst not dispositive of these issues, in my view it is useful context to consider the conclusions of the FAC having examined the evidence presented to them on these matters. This is set out above, and it will be noted that, in particular, having observed in paragraph 40 of their report that they were "seriously concerned that products and materials made from Uyghu
- 83. r forced labour are making their way into UK value chains", at paragraph 48 of their report in the light of the available evidence the FAC proposed the imposition of an assumption that any product originating in the XUAR should be assumed to be the product of forced labour. The presumption could be displaced by definitive proof that the product was not tainted by forced labour. This recommendation of the FAC was undoubtedly made in recognition of the difficulties of establishing the necessary proof in relation to a specific consignment of goods that it was produced by forced, detained or imprisoned labour. Given the evidential difficulties which the FAC records in relation to monitoring the cotton industry in the XUAR a reversal of the burden of proof (alongside consideration of an import ban) was the suggested solution. The adoption of this solution by the FAC underlines the difficulties of deploying the offences in Part 7 of the 2002 Act in this context.
- 84. Beyond the problems which I accept exist in relation to the proof of criminal property, there are additional specific problems in pursuing the offences under section 328 and 329 with the material currently available. In respect of section 328 it would, in addition, to the requirements of proving criminal property, be necessary to prove that the accused person knew or suspected that the arrangement into which he was entering facilitated the acquisition, retention use or control of criminal property. The establishing of this further mens rea of this offence will, as the Defendant points out, create further complexity to proving the existence of the offence, in particular in the context of a lengthy international value chain.
- 85. In relation to section 329 there is the added complexity, in particular in the context of a value chain of the kind under consideration, of the exemption under section 329(2)(c) in relation to the acquisition of the property for adequate consideration. Whilst the Claimant raises various concerns rehearsed above in relation to the interpretation of this provision, in my judgment the answer to these submissions is to be found in the case of *Hogan* set out above. This authority provides a definitive interpretation which supports the concerns of the Defendant in respect of the practicality of prosecuting the section 329 offence in relation to acquisition. It would not only be necessary to show that a consignment was criminal property, but also that, considering the question objectively, the consignment had been purchased for significantly less than its value or by some other measure for consideration which was not adequate. This requirement presents difficulties in the context of the international trading of the goods which are in question in this case, and it appears to me that the Defendant has set out legitimate and

understandable concerns in relation to establishing criminal liability under section 329 of the 2002 Act in the light of the exemption in section 329(2)(c).

- 86. In short, having examined the submissions in relation to the 2002 Act I am satisfied that there is no misdirection evident in paragraph 32 of the Defendant's letter of 10th September 2021. The understanding of the requirements of section 340 in relation to the proof of criminal property is consistent with authority and accurate. It was understandable that the focus of paragraph 32(ii) was on section 329 of the 2002 Act given the nature of the evidence provided to the Defendant bearing upon the value chain in question in this case, and the observations in relation to the difficulties presented by section 329(2)(c) were again entirely appropriate and reflected a proper understanding of the relevant legal principles. The focus of paragraph 32(ii) on section 329 was not a misdirection given that the concerns in relation to section 340 set out in paragraph 32(i) obviously relate to all of the offences under consideration. The letter of the 10th September 2021 therefore demonstrates that the Defendant was correctly directing the assessment of the Claimant's concerns at the time of reaching the decisions in this case.
- 87. The Claimant is also critical, in particular in their submissions on Ground 4, of what they contend is a failure to deploy civil powers of investigation and recovery under Part 5 of the 2002 Act. In my view the Defendant is entitled to rely upon the same issues and concerns in relation to the specificity of the evidence in this connection as is relied upon in response to Ground 3. Albeit that the standard of proof is civil rather than criminal, there is still a need for it to be demonstrated that the specific property which is being examined was the product of unlawful conduct, along with the necessary particulars of the unlawful conduct to which it was subject. Similar issues arise in relation to the specific consignment is properly to be regarded as meeting the definition of property which is, or which represents, property obtained by unlawful conduct, even as enlarged by the provisions of section 241A of the 2002 Act.
- 88. Further, in my view the Claimant's criticisms in relation to the failure to undertake further investigation need to be set in context. Firstly, it is important to appreciate that the Defendant has not been inert or unresponsive with regard to the concerns presented by the Claimant. As set out above, all of the material which is before the court has, prior to these proceedings, been sent to the Defendant for consideration and evaluation. The Defendant's response was set out in the letter of the 10th September 2021 in the following terms:

"33. As for the specific questions raised at §49 of the Letter Before Claim concerning the specific steps taken by the NCA to date concerning specific suppliers in XUAR:

- (i) The NCA International Liaison Office in Beijing; the head of the Modern Slavery Tactical Advisors Team; and the Modern Slavery Intelligence Development Team, have reviewed the information sent by your client to HMRC and passed to the NCA. Their assessment of the matter has not changed.
- (ii) The information received from your client to date has consisted of expert opinions, news articles and committee reports. As noted above, nothing has been identified which provides a concrete allegation of modern slavery upon which the NCA could commence an investigation. The NCA therefore remains at the stage of initial intelligence gathering. No further investigative steps have yet been taken such as are suggested at §49 of the Letter Before Claim.

- (iii) The NCA note that your client takes the view that there are suspicions of criminality, however, the NCA's view remains that there are not currently sufficient grounds to suspect that any identifiable criminal offence has been committed by identifiable individuals.
- (iv) The NCA remains open to the possibility that the intelligence picture may change at any time.

34. In the present circumstances, there is no basis on which to compel any investigation into alleged money laundering."

- 89. It is clear from this paragraph that the material furnished by the Claimant has been the subject of active examination but, applying the principles set out in paragraph 32 of the same letter, was not considered to give rise to a basis for further enquiry at that time. The possibility of other information or intelligence coming to light and requiring investigation was not closed off and remains open.
- 90. Secondly by way of context, as has been set out above, I accept the Defendant's submissions which are relevant to Ground 1 as well as Grounds 3 and 4 in relation to the absence of the necessary specificity in the evidence. That absence of specificity justifies the conclusions reached by the Defendant in relation to both the 1897 Act and also the 2002 Act, both in relation to the criminal offences it creates and also in relation to the civil powers which similarly require specific evidence. It also supports the conclusion which the Defendant reached that there would be little if any purpose to be served by pursuing an investigation which would not bear fruit in the form of prosecutions or seizures.
- 91. The third important piece of context is the scope of the court's jurisdiction based on the authorities such as *Corner House*, which reflect that the court will be slow to interfere with the exercise of investigatory and prosecution powers that are vested in parties such as the Defendant in the present case. As was repeatedly observed on both sides of the case during the hearing, the Claimant does not advance a case based on *Wednesbury* unreasonableness, and on the authorities it would be very challenging for the Claimant to do so. This is a case focussed on alleged misdirections of law, not a challenge to the rationality of the decisions described in paragraphs 33 and 34 of the letter of 10th September 2021.
- 92. Once the Claimant's concerns are placed into context then in my view this provides additional support for the conclusion that there is no substance in the Claimant's Ground 4 and no basis for the grant of any relief in respect of it.

Conclusions

93. It will be apparent from the examination of the Claimant's grounds set out above that I have reached the conclusion that none of them are made out and that relief should be refused. It would, however, be inappropriate to leave this judgment without emphasising the limited role that the court has in relation to a challenge of this kind. The outcome of the case does not in any way undermine the striking consensus in the evidence that there are clear and widespread abuses in the cotton industry in the XUAR, involving human rights violations and the exploitation of forced labour. It is clear that

these agreed concerns continue to trouble the Defendant and are the subject of active policy work and engagement. The task of the court in this case has been to determine whether the legal tools alighted upon by the Claimant have been properly understood by the Defendant in taking the approach which they have to the Claimant's evidence. The conclusion is that there has been no error in the Defendant's analysis. That is not to say that there may be other tools or measures available to the executive and law enforcement agencies, or other evidence which they could receive meeting the requirements upon which the Defendant has correctly relied in this challenge, which could provide an effective basis for tackling the concerns in respect of cotton production in the XUAR and the exploitation and abuse of the Uyghur people with which it has been associated.
