Social Security (Deferral of Retirement Pensions) Regulations (Northern Ireland) 2011

Made - - - - 15th March 2011

Coming into operation in accordance with regulation 1

The Department for Social Development makes the following Regulations in exercise of the powers conferred by section 171(1) and (3) of, and paragraphs 2(2), 3B(2) and (5)(b)(iii) and 7B(2) and (5)(b)(iii) of Schedule 5 and paragraph 5(2) of Schedule 5A to, the Social Security Contributions and Benefits (Northern Ireland) Act 1992(a), and now vested in it(b).

Citation and commencement

- 1.—(1) These Regulations may be cited as the Social Security (Deferral of Retirement Pensions) Regulations (Northern Ireland) 2011.
 - (2) Regulations 3(2) and (3), 4 and this regulation shall come into operation on 5th April 2011.
 - (3) The other provisions of these Regulations shall come into operation on 6th April 2011.

Amendment of the Social Security (Widow's Benefit and Retirement Pensions) Regulations

- **2.**—(1) Regulation 4 of the Social Security (Widow's Benefit and Retirement Pensions) Regulations (Northern Ireland) 1979(c) (days to be treated as days of increment) is amended in accordance with paragraphs (2) and (3).
 - (2) In paragraph (1)—
 - (a) in sub-paragraph (b)(iii)(d) for "and" substitute "or";
 - (b) after sub-paragraph (b)(iii) insert—
 - "(iv) state pension credit under section 1 of the State Pension Credit Act (Northern Ireland) 2002(e); and";
 - (c) after sub-paragraph (d)(f) add—

"; and

- (e) in the case of a person who was a member of a couple, the other member of the couple was not in receipt of—
 - (i) income support under section 123 of the Contributions and Benefits Act;
 - (ii) income-based jobseeker's allowance under Article 3 of the Jobseekers (Northern Ireland) Order 1995(a);
 - (iii) state pension credit under section 1 of the State Pension Credit Act (Northern Ireland) 2002; or
 - (iv) income-related employment and support allowance under section 1 of the Welfare Reform Act (Northern Ireland) 2007(b).".
- (3) After paragraph (4)(c) add—
 - "(5) In paragraph (1), "couple" has the meaning given by section 133(1) of the Contributions and Benefits Act(d).".
- (4) This regulation applies only in respect of a day falling on or after 6th April 2011.

Amendment of the Social Security (Deferral of Retirement Pensions) Regulations

- **3.**—(1) The Social Security (Deferral of Retirement Pensions) Regulations (Northern Ireland) 2005(e) are amended in accordance with paragraphs (2) to (4).
- (2) In regulation 1(2) (interpretation), after the definition of the "Contributions and Benefits Act" insert—

"the Claims and Payments Regulations" means the Social Security (Claims and Payments) Regulations (Northern Ireland) 1987(f).".

- (3) For regulation 2 (beginning of accrual period), substitute—
 - "2.—(1) This regulation applies for the purposes of paragraphs 3B and 7B of Schedule 5 and paragraph 5 of Schedule 5A to the Contributions and Benefits Act (calculation of lump sum).
 - (2) In the case of a retirement pension or shared additional pension to which regulation 22 of the Claims and Payments Regulations(g) (long term benefits) applies, the accrual period shall begin with the day of the week on which benefit would have been payable had entitlement not been deferred.
 - (3) In the case of a retirement pension to which regulation 22C of the Claims and Payments Regulations(h) (retirement pension for persons reaching pensionable age on or after 6th April 2010) applies, the accrual period shall begin with the first day of the benefit week in relation to which benefit would have been payable had entitlement not been deferred.
 - (4) In this regulation, "benefit week" has the same meaning as in regulation 22D of the Claims and Payments Regulations(i) (payment of retirement pension at a daily rate)."
- (4) In regulation 3 (amount of retirement pension not included in the calculation of the lump sum)—

 - (iii) state pension credit under section 1 of the State Pension Credit Act (Northern Ireland) 2002; or
 - (iv) income-related employment and support allowance under section 1 of the Welfare Reform Act (Northern Ireland) 2007;".
- (b) in paragraphs (2) and (4) after "paragraph (1)(a)" insert "or (aa)".
- (c) after paragraph (5) insert—
 - "(5A) In paragraph (1), "couple" has the meaning given by section 133(1) of the Contributions and Benefits Act.".
- (5) Paragraph (4) applies only in respect of an accrual period, or part of an accrual period, falling on or after 6th April 2011.

Revocation

4. Regulation 8(3) of the Social Security (Shared Additional Pension) (Miscellaneous Amendments) Regulations (Northern Ireland) 2005(a) is revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Social Security (Widow's Benefit and Retirement Pensions) Regulations (Northern Ireland) 1979 (the "1979 Regulations") and the Social Security (Deferral of Retirement Pensions) Regulations (Northern Ireland) 2005 (the "2005 Regulations").

If a person defers entitlement to a state pension, that person may become entitled to a higher rate of state pension or a lump sum ("deferral benefits"), which accrue over time while the benefit remains unclaimed.

These Regulations amend regulation 4 of the 1979 Regulations and regulation 3 of the 2005 Regulations to provide that:

- a person does not accrue any deferral benefits while that person is in receipt of state pension credit;
- a person does not accrue any deferral benefits where that person is a member of a couple and the other member of the couple is in receipt of income support, income-based jobseeker's allowance, state pension credit or income-related employment and support allowance.

Regulation 3(3) amends the 2005 Regulations to prescribe the day of the week on which an accrual period begins for the purposes of paragraphs 3B and 7B of Schedule 5 and paragraph 5 of Schedule 5A to the Social Security Contributions and Benefits (Northern Ireland) Act 1992.

Schedule 5 to that Act deals with increasing a pension or paying a lump sum where entitlement to a retirement pension is deferred. Schedule 5A to that Act deals with increasing a pension or paying a lump sum where entitlement to a shared additional pension is deferred. Paragraphs 3B and 7B of Schedule 5, and paragraph 5 of Schedule 5A, deal with the calculation of a lump sum. In each case, a lump sum is calculated by reference to accrual periods, being a period of seven days within a period of deferment beginning with a prescribed day of the week.

Regulation 4 makes a consequential revocation.

These Regulations make in relation to Northern Ireland only provision corresponding to provision contained in Regulations made by the Secretary of State for Work and Pensions in relation to Great Britain and accordingly, by virtue of section 149(3) of, and paragraph 10 of Schedule 5 to, the Social Security Administration (Northern Ireland) Act 1992, are not subject to the requirement of section 149(2) of that Act for prior reference to the Social Security Advisory Committee.
