**ROAD TRAFFIC AND VEHICLES**

**The Prohibition of Waiting (Amendment) Order (Northern Ireland) 2011**

*Made* - - - - - *16th May 2011*

*Coming into operation* - *7th June 2011*

The Department for Regional Development<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Prohibition of Waiting (Amendment) Order (Northern Ireland) 2011 and shall come into operation on 7th June 2011.

**Amendment**

2. The Schedule to The Prohibition of Waiting Order (Northern Ireland) 2001<sup>(d)</sup> shall be amended by—

(a) the addition to Schedule 1 of the following item—

“10. Sackville Street, Lisburn (south-west side) – from a point 46 metres north-west of its junction with Wallace Avenue for a distance of 25.6 metres in a north-westerly direction.	8.00 a.m. to 9.15 a.m. 1.45 p.m. to 3.15 p.m.	Monday to Friday inclusive”

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order further amends the Prohibition of Waiting Order (Northern Ireland) 2001 (“the Order”). The amendments prohibit waiting by vehicles, with certain exceptions, on a length of Sackville Street, Lisburn at the times and on the days specified and a length of Ashgrove Road, Newtownabbey, at the times and on the days and during the period specified (Article 2).

A penalty charge (£60) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the roads.
