Citation and commencement

1. This Order may be cited as The One-Way Traffic (Belfast) (Amendment No. 3) Order (Northern Ireland) 2011 and shall come into operation on 2nd January 2012.

EXPLANATORY NOTE

(This note is not part of the Order)

The effect of this Order is to amend The One-Way Traffic (Belfast) Order (Northern Ireland) 2009 ("the Order") by revoking the items specified in Article 2(2) and adding the items specified in Article 2(3) to Schedule 1 to the Order. This will reduce the lengths of the one-way restrictions on Bruce Street and Hope Street, Belfast.

Any person who acts in contravention of the Order shall be guilty of an offence under the Road Traffic Regulation (Northern Ireland) Order 1997 ("the Regulation Order") and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (£1,000) in accordance with the Road Traffic Offenders (Northern Ireland) Order 1996 as amended by the Regulation Order.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
