ROAD TRAFFIC AND VEHICLES

**The Parking Places (Disabled Persons' Vehicles) (Amendment
No. 2) Order (Northern Ireland) 2011**

Made - - - - *10th March 2011*

Coming into operation - *1st April 2011*

The Department for Regional Development^(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16), and 15(1) and (4) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the road specified in the Schedule.

The Department has considered both the interests of traffic and those of the owners and occupiers of adjoining property in accordance with Article 15(2) of the Road Traffic Regulation (Northern Ireland) Order 1997 and has had regard to the matters specified in Article 15(3) of that Order.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2011 and shall come into operation on 1st April 2011.

Amendments

2.—(1) The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006(a) shall be amended in accordance with paragraphs (2) to (7).

(2) In Article 2 (authorisation of parking places) for the words "Schedules 1, 2, 3, 4, 5 and 6" substitute "Schedules 1, 2, 3, 4, 5, 6 and 7".

(3) In Article 3 (use of parking places) in paragraph (a) for the words "3 or 4" substitute "3, 4, 6 or 7".

(4) After Article 3AC insert the following Article—

3AD. Except as set out in Article 4, the driver of a disabled persons' vehicle shall not permit it to wait in a parking place specified in Schedule 7 for longer than 2 hours between the hours of 8.30 a.m. and 6.15 p.m. on any day from Monday to Saturday."

(5) After Article 3E insert the following Article—

3F. Except as set out in Article 4, where a disabled persons' vehicle has waited in a parking place specified in Schedule 7 between the hours of 8.30 a.m. and 6.15 p.m. on any day from Monday to Saturday, then the driver of that vehicle shall not permit it to return to that parking place until the period of 3 hours has elapsed since the previous period of waiting or until 6.15 p.m., whichever is the shorter period."

(6) In Article 4 (exceptions) for the words "Articles 3, 3A, 3AA, 3AB, 3AC, 3B, 3C, 3D and 3E" substitute the words "Articles 3, 3A, 3AA, 3AB, 3AC, 3AD, 3B, 3C, 3D, 3E and 3F".

(7) After Schedule 6 add the Schedule set out in the Schedule to this Order.

3. Schedule 1 to The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2006(b) shall be amended by the deletion of item no. 1125 relating to Monaghan Street, Newry.

4.—(1) The On-Street Parking Order (Northern Ireland) 2000(c) shall be amended in accordance with paragraph (2).

(2) For item 9 of Chapter 3 of Part 1 of Schedule 1 substitute the following item—

SCHEDULE

Article 2 (7)

“SCHEDULE 7

Waiting limited to 2 hours on Monday to Saturday between 8.30 a.m. and 6.15 p.m. with return prohibited within 3 hours.

1. Monaghan Street, Newry (north side) – from a point 70 metres west of its junction with Merchant’s Quay for a distance of 5 metres.
2. Monaghan Street, Newry (north side) – from a point 92 metres west of its junction with Merchant’s Quay for a distance of 6 metres.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006 and The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2006. The amendments provide for the introduction of parking places with limited waiting on the lengths of the road specified in the Schedule to this Order (Article 2) and the removal of the parking place referred to in Article 3.

The lengths of the road specified in the Schedule to this Order are presently contained within a parking place designated under Article 5 of, and Schedule 1 to, the On-Street Parking Order (Northern Ireland) 2000 ("the 2000 Order"). This Order also amends the 2000 Order by redefining the designated parking place in question to exclude these lengths of the road (Article 4).
