ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 5) Order (Northern Ireland) 2013

Made - - - - 27th September 2013

Coming into operation - 17th October 2013

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

Two objections have been received and no other representations were received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 5) Order (Northern Ireland) 2013 and shall come into operation on 17th October 2013.

Article 2(3)

Unlimited Waiting

- "947. Inverary Avenue, Belfast (north-east side) from a point 77 metres north-west of its junction with Holywood Road, for a distance of 2.5 metres in a north-westerly direction.
- 948. Main Street, Dungiven (south-west side) from a point 23 metres north-west of its junction with Kevin Lynch Park, for a distance of 6.5 metres in a north-westerly direction.
- 949. Main Street, Dungiven (south-west side) from a point 62 metres north-west of its junction with Sawell Place, for a distance of 6.5 metres in a north-westerly direction.
- 950. Spelga Place, Kilkeel (south-west side) from a point 68 metres south-east of its junction with Knockchree Avenue, for a distance of 7.2 metres in a south-easterly direction.
- 951. Osborne Drive, Shrigley, Killyleagh (west side) from a point 15 metres north of its junction with Woodland Crescent, for a distance of 6 metres in a northerly direction.
- 952. Ardcarne Park, Newry (in a lay-by on the south-west side) from a point 313 metres south of its junction with Carnagat Road, for a distance of 4.8 metres in a north-westerly direction.
- 953. Listooder Gardens, Saintfield (north side) from a point 64 metres north of its junction with Listooder Park, for a distance of 8.3 metres in an easterly direction.
- 954. The Square, Stewartstown (east side) from a point 21 metres south of its junction with West Street, for a distance of 6.5 metres in a southerly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006 and The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2006.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule, and the removal of the parking places referred to in Articles 2(2) and 3(2).
