ROAD TRAFFIC AND VEHICLES

The Roads (Speed Limit) Order (Northern Ireland) 2014

Made - - - - *18th March 2014*

Coming into operation - *8th April 2014*

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 37(3), 37(4) and 38(1)(a) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Roads (Speed Limit) Order (Northern Ireland) 2014 and shall come into operation on 8th April 2014.

Speed restriction on certain roads

2. The Department directs that the lengths of road specified in Schedule 1 shall be restricted roads.

Application of speed limits

3. The driving of motor vehicles at a speed exceeding 20 miles per hour on the roads specified in Schedule 2 is prohibited.

4. The driving of motor vehicles at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 3 is prohibited.

Revocations

5. The provisions described in Schedule 4 are revoked.

SCHEDULE 1

Article 2

Restricted lengths of road

1. Laburnum Road, Unclassified No. 2229, Glack, Limavady, from its junction with Tartnakilly Road, Unclassified No. 2228, for a distance of 184 metres in a north-westerly direction.
2. Laurel Road, Unclassified No. 2230, Glack, Limavady, from its junction with Tartnakilly Road, Unclassified No. 2230, for a distance of 216 metres in a southerly direction.
3. Tartnakilly Road, Unclassified Nos. 2228 and 2230, Glack, Limavady, from a point 108 metres south-west of its junction with Laburnum Road, Unclassified No. 2229, to a point 325 metres north-east of its junction with Laurel Road, Unclassified No. 2230.
4. Learmount Road, Route C509-3, Park, County Londonderry, from a point 58 metres south-west of its junction with Tireighter Road, for a distance of 100 metres in a south-westerly direction.

Lengths of road subject to a speed limit of 40 miles per hour

1. Tartnakilly Road, Unclassified No. 2228, Glack, Limavady, from a point 200 metres north-west of its junction with Larch Road, Unclassified No. 2228, to a point 58 metres east of that junction.
2. Monaghan Road, Route A3, Middletown, from a point 335 metres west of Coolkill Road, Route B210, to a point 565 metres west of that junction.
3. Monaghan Road, Route A3, Middletown, from a point 115 metres north-east of Coolkill Road, Route B210, to a point 405 metres east of that junction.

Article 5

Revocations

Items 23, 181 and 243 of the Schedule to the Roads (Speed Limit) (No. 10) Order (Northern Ireland) 1997^(a).

EXPLANATORY NOTE

(This note is not part of the Order)

This Order—

- (a) makes the lengths of road specified in Schedule 1 restricted roads;
- (b) applies a speed limit of 20 miles per hour to the roads specified in Schedule 2;
- (c) applies a speed limit of 40 miles per hour to the lengths of road specified in Schedule 3;
and
- (d) revokes the provisions in Schedule 4.

In relation to the revoked provisions in Schedule 4—

- 1.** The speed limit on Glack Cottages, Glack, Limavady (item 23) is now 30 miles per hour (restricted by street lighting).
- 2.** The speed limit on the length of Tartnakilly Road, Glack, Limavady (item 181) is now included in a longer length of road at 30 miles per hour (restricted by street lighting).
- 3.** The speed limit on the length of Tartnakilly Road, Glack, Limavady (item 243) is now included in a longer length of road at 30 miles per hour (restricted by street lighting).
