ROAD TRAFFIC AND VEHICLES

The Parking Places on Roads (Disabled Persons' Vehicles)
(Amendment) Order (Northern Ireland) 2015

Made - - - - 28th May 2015

Coming into operation - 17th June 2015

The Department for Regional Development(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedules.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

Five objections have been received and duly considered and no other representations were received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as The Parking Places on Roads (Disabled Persons' Vehicles) (Amendment) Order (Northern Ireland) 2015 and shall come into operation on 17th June 2015.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2015.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of road specified in Schedule 1 and the introduction of a parking place with limited waiting limited on the length of road specified in Schedule 2, the removal of the parking places referred to in Article 2(2)(a) and the amendment of the items specified in Article 2(2)(c) and 2(2)(d).
