Coming into operation - 12th October 2015

The Department for Regional Development(\mathbf{a}) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(\mathbf{b}) and now vested in it(\mathbf{c}).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Prohibition of Waiting (Amendment No. 2) Order (Northern Ireland) 2015 and shall come into operation on 12th October 2015.

2. The Prohibition of Waiting Order (Northern Ireland) 2001(**d**) is amended by the addition to Schedule 2 of the following item—
