Coming into operation - 19th October 2015

The Department for Regional Development(**a**) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking and Waiting Restrictions (Banbridge) (Amendment) Order (Northern Ireland) 2015 and shall come into operation on 19th October 2015.

Amendment

- **2.**—(1) The Parking and Waiting Restrictions (Banbridge) Order (Northern Ireland) 2014(**d**) is amended in accordance with paragraphs (2) and (3).
 - (2) In Article 11(b) for the words "the length" substitute the words "the lengths".
 - (3) For Part 3 of Schedule 2 substitute the Part as set out in the Schedule to this Order.

"PART 3

No Waiting Monday to Saturday — 8.30 a.m. to 6.15 p.m. — Loading and Unloading not permitted

- 1. Rathfriland Street, (north-east side) from a point 20 metres south-east of its junction with Gospel Lane for a distance of 94 metres in a south-easterly direction.
- 2. Kenlis Street, (south side) from a point 19 metres east of its junction with Townsend Street for a distance of 20 metres in an easterly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Banbridge) Order (Northern Ireland) 2014 ("the Order") by the addition to Part 3 of Schedule 2 to that Order of a length of Kenlis Street, Banbridge.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
