# The Parking and Waiting Restrictions (Belfast) (Amendment No. 5) Order (Northern Ireland) 2016

*Made - - - - 13th December 2016* 

Coming into operation - 3rd January 2017

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 4(1), (2) and (3), 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide a suitable parking place for vehicles on the length of the road specified in Article 2(2).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedules 1 and 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of those Schedules.

The Department, in compliance with paragraph 3(4) of Schedule 4 to that Order, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking place the particulars specified in paragraph 3(2) of that Schedule.

Two written objection were received and duly considered and no other representation has been received.

#### Citation and commencement

**1.** This Order may be cited as The Parking and Waiting Restrictions (Belfast) (Amendment No. 5) Order (Northern Ireland) 2016 and shall come into operation on 3rd January 2017.

#### Amendment

**2.**—(1) The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2016(**d**) is amended in accordance with paragraphs (2) and (3).

- (2) Part 2 of Schedule 1 is amended by the addition of the following item—
  - "22. Rugby Avenue (north side) from a point 50 metres west of its junction with Ormeau Road, Route A24, for a distance of 28 metres in a westerly direction."
- (3) Part 1 of Schedule 2 is amended by the addition of the following items—
  - "58. Belmont Church Road (east side) from a point 15 metres north of its junction with Upper Newtownards Road for a distance of 17 metres in a northerly direction.
  - 59. Cabin Hill Park (east side) from a point 15 metres south of its junction with Upper Newtownards Road for a distance of 24 metres in a southerly direction.
  - 60. Cabin Hill Park (west side) from a point 15 metres south of its junction with Upper Newtownards Road for a distance of 35 metres in a southerly direction."

### **EXPLANATORY NOTE**

This Order amends The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2016 ("the Order") by the addition to Schedules 1 and 2 of the items specified in Article 2.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
