# The Parking and Waiting Restrictions (Belfast) (Amendment No. 5) Order (Northern Ireland) 2017

Made - - - - 24th August 2017

Coming into operation - 18th September 2017

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide a suitable parking place for vehicles on the length of the road specified in Article 2.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 of the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department, in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purposes of bringing specifically to the knowledge of the occupiers of land adjacent to the parking place the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

#### Citation and commencement

**1.** This Order may be cited as The Parking and Waiting Restrictions (Belfast) (Amendment No. 5) Order (Northern Ireland) 2017 and shall come into operation on 18th September 2017.

#### Amendment

**2.** The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2016(**d**) is amended by the addition to Part 2 of Schedule 1 of the following item—

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2016 ("the Order") by the addition to Schedule 1 of the item specified in Article 2.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
