# The Parking and Waiting Restrictions (Londonderry) (Amendment) Order (Northern Ireland) 2017

Made	-	28th February 2017
Coming into operation	-	22nd March 2017

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

#### **Citation and commencement**

**1.** This Order may be cited as The Parking and Waiting Restrictions (Londonderry) (Amendment) Order (Northern Ireland) 2017 and shall come into operation on 22nd March 2017.

#### Amendment

**2.** The Parking and Waiting Restrictions (Londonderry) Order (Northern Ireland) 2015(**d**) is amended by the addition to Schedule 3 of the following items—

- "41. Airport Road, Route C582 (north-west side) from Airport Roundabout, Route B118, for a distance of 130 metres in a south-westerly direction.
- 42. Airport Road, Route C582 (south-east side) from Airport Roundabout, Route B118, for a distance of 130 metres in a south-westerly direction.
- 43. Airport Link Road, Route B118 (east side) from Airport Roundabout, Route B118, for a distance of 71.5 metres in a southerly direction.
- 44. Airport Link Road, Route B118 (west side) from Airport Roundabout. Route B118, for a distance of 71.5 metres in a southerly direction.

- 45. Airport Terminal Link, Route B118 (north side) from Airport Roundabout, Route B118, for its entire length.
- 46. Airport Terminal Link, Route B118 (south side) from Airport Roundabout, Route B118, for its entire length.
- 47. Longfield Industrial Estate Link, Route C582 (north-west side) from Airport Roundabout, Route B118, for a distance of 50 metres in a north-easterly direction.
- 48. Longfield Industrial Estate Link, Route C582 (south-east side) from Airport Roundabout, Route B118, for a distance of 50 metres in a northeasterly direction."

### **EXPLANATORY NOTE**

#### (This note is not part of the Regulations)

This Order amends The Parking and Waiting Restrictions (Londonderry) Order (Northern Ireland) 2015 ("the Order") by the addition of a 'no waiting at any time' restriction on the lengths of road specified in Article 2.

Vehicles are excepted from the prohibition in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the roads.
