ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2018

Made - - - - 29th August 2018

Coming into operation - 18th September 2018

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2018 and shall come into operation on 18th September 2018.

Unlimited Waiting

- "2553. Burmah Street, Belfast (south-west side) from a point 78 metres south-east of its junction with Ava Avenue for a distance of 5.5 metres in a south-easterly direction.
- 2554. Knocknagoney Drive, Belfast (south side in a parking area) from a point 48 metres west of its junction with Knocknagoney Grove for a distance of 3 metres in a westerly direction.
- 2555. Rathmore Street, Belfast (north-east side) from a point 18.5 metres south-east of its junction with Mount Street South for a distance of 3 metres in a south-easterly direction.
- 2556. Ulsterville Gardens, Belfast (north-east side) from a point 157 metres south-east of its junction with Fane Street, for a distance of 5.5 metres in a south-easterly direction.
- 2557. Willowholme Drive, Belfast (west side) from a point 33 metres south of its junction with Willowholme Street for a distance of 5.5 metres in a southerly direction.
- 2558. Beresford Avenue, Coleraine (west side) from a point 27 metres north of its junction with Mount Street for a distance of 6.5 metres in a northerly direction.
- 2559. Northland Way, Londonderry (north-west side) from a point 25 metres northeast of its junction with Academy Road for a distance of 6 metres in a northeasterly direction"

EXPLANATORY NOTE

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking place referred to in Article 2(2).
