ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2019

Made - - - - 2nd December 2019

Coming into operation - 23rd December 2019

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedules.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2019 and shall come into operation on 23rd December 2019.

Article 2

Waiting limited to 2 hours on Monday to Friday between 8.00 a.m. and 6.00 p.m. with return prohibited within 1 hour

- 1. Duncairn Gardens, Belfast (south-west side) from a point 114 metres north-west of its junction with North Queen Street for a distance of 5.5 metres.
- 2. Bryson Street, Belfast (north-east side) from a point 15 metres south-east of its junction with Newtownards Road for a distance of 6.6 metres in a south-easterly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of road specified in Schedule 1 and a parking place with limited waiting in Bryson Street, Belfast. The Order also removes the parking places referred to in Article 2(2)(a) and the amendment of the item referred to in Article 2(2)(b).
