The Education (Student Support) (Amendment) (No.2) Regulations (Northern Ireland) 2020

Made - - - - 17th July 2020 Coming into operation 7th August 2020

The Department for the Economy (1) in exercise of the powers conferred by Articles 3 and 8(4) of the Education (Student Support) (Northern Ireland) Order 1998(2) makes the following Regulations.

PART 1

GENERAL

Citation, commencement and application

- 1.—(1) These Regulations may be cited as the Education (Student Support) (Amendment) (No. 2) Regulations (Northern Ireland) 2020 and come into operation on 7th August 2020.
- (2) The following regulations apply in relation to the provision of support to a student in relation to an academic year which begins on or after 1st August 2020, whether or not anything done under these regulations is done before, on, or after that date.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amends the Education (Student Support) (No. 2) Regulations (Northern Ireland) 2009/373 ("the Student Support Regulations").

Regulation 3 corrects an omission of a figure from the Education (Student Support) (Amendment) Regulations (Northern Ireland) 2020 and increases this figure in line with inflation.
