# ROAD TRAFFIC AND VECHICLES

The Parking Places, Loading Bay and Waiting Restrictions (Portstewart) (Amendment) Order (Northern Ireland) 2020

Made - - - - 13th August 2020

Coming into operation - 7th September 2020

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide a suitable parking place for vehicles on the length of the road specified in Article 3.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking place the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

### Citation and commencement

**1.** This Order may be cited as The Parking Places, Loading Bay and Waiting Restrictions (Portstewart) (Amendment) Order (Northern Ireland) 2020 and shall come into operation on 7th September 2020.

#### Amendments

**2.** The Parking Places, Loading Bay and Waiting Restrictions (Portstewart) Order (Northern Ireland)  $2010(\mathbf{d})$  is amended by the substitution for item no. 1 in Part 1 of Schedule 1 of the following item—

- "1. The Diamond (service road), Portstewart (west side) from a point 11 metres north of its junction with Strand Road for a distance of 33 metres."
- **3.** The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016(a) is amended by the addition to Schedule 1 of the following item—
  - "2781. The Diamond (service road), Portstewart (west side) from a point 44 metres north of its junction with Strand Road for a distance of 6.5 metres in a northerly direction."

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order amends The Parking Places, Loading Bay and Waiting Restrictions (Portstewart) Order (Northern Ireland) 2010 ("the Order") by reducing the length of the existing parking place with limited waiting on the length of road specified in Article 2.

The Order also amends the Parking Places (Disabled Persons' Vehicles) (Order) (Northern Ireland) 2016 by the addition to Schedule 1 of a parking place with unlimited waiting for disabled persons' vehicles on the length of road specified in Article 3.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
