The Department for Infrastructure(a) makes the following Order in exercise of its powers conferred by Article 68(1), (3) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order is of the opinion that the length of road described in the Schedule is not necessary for road traffic.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation and commencement

1. This Order may be cited as The A26 Crankill Road Central Reservation, Ballymena (Stopping-Up) Order (Northern Ireland) 2020 and shall come into operation on 27th January 2021.

Application

- **2.**—(1) The length of road described in the Schedule shall be stopped-up to road traffic at the line specified therein.
- (2) The Department shall carry out such works as it considers necessary to prevent or restrict to such extent as the Department thinks fit, access to the length of road described in the Schedule by road traffic.
- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the road to be stopped-up shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.
