# ROAD TRAFFIC AND VEHICLES

The On-Street Parking (Residents Parking Zone – Rugby Road / College Park Avenue Area, Belfast) (Amendment) Order (Northern Ireland) 2021

Made - - - - 13th May 2021

Coming into operation - 7th June 2021

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 4(1), (2) and (3), 15(1) and (4) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department in compliance with Article 15(2) and (3) of The Road Traffic Regulation (Northern Ireland) Order 1997 has considered both the interests of traffic and those of the owners and occupiers of adjoining property.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedules 1 and 4 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of those Schedules.

The Department in compliance with paragraph 3(4) of Schedule 4 to that Order has taken such other steps as appear to it reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking place the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

#### Citation and commencement

**1.** This Order may be cited as The On-Street Parking (Residents Parking Zone – Rugby Road / College Park Avenue Area, Belfast) (Amendment) Order (Northern Ireland) 2021 and shall come into operation on 7th June 2021.

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order amends The On-Street Parking (Residents Parking Zone – Rugby Road/College Park Avenue Area, Belfast) Order (Northern Ireland) 2017 ("the Order") by removing a no waiting at any time restriction on 2 lengths of College Green, Belfast and amending the parking provision within the controlled parking zone.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with The Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.
