ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 5) Order (Northern Ireland) 2021

Made - - - - 16th June 2021

Coming into operation - 8th July 2021

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

Five objections have been received and duly considered and no other representation has been received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 5) Order (Northern Ireland) 2021 and shall come into operation on 8th July 2021.

"2940.	Ballysillan Drive, Belfast (south side) – from a point 50 metres south-west of its junction with Tyndale Drive for a distance of 5.5 metres in a south-westerly direction.
2941.	Cregagh Street, Belfast (south side) – from a point 88.5 metres west of its junction with Cregagh Road for a distance of 5.3 metres in a westerly direction.
2942.	Kimberley Street, Belfast (south-east side) – from a point 83 metres north-east of its junction with Haywood Avenue for a distance of 5.5 metres in a north-easterly direction.
2943.	Lisavon Drive, Belfast (south-west side) – from a point 68 metres north-west of its junction with Lisavon Street for a distance of 5.5 metres in a north-westerly direction.
2944.	Oakman Street, Belfast (south-east side) - from a point 48 metres north-east of its junction with Beechmount Avenue for a distance of 5.5 metres in a north-easterly direction.
2945.	Pacific Avenue, Belfast (north-east side) – from a point 20 metres north-west of its junction with Atlantic Avenue for a distance of 5.5 metres in a north-westerly direction.
2946.	Stracam Corner, Belfast (north-west side of a parking area) – from a point 87 metres south-east and then 61 metres north-east of The Straight for a distance of 3 metres in a north-easterly direction.
2947.	Strandburn Gardens, Belfast (north-west side) – from a point 32 metres north-east of its junction with Connsbrook Drive for a distance of 5.5 metres in a north-easterly direction.
2948.	Laganvale, Dromore, County Down (south-west corner of cul-de-sac, in front of No. 4) – from a point 60 metres south-west of its junction with Meeting Street for a distance of 6 metres in a south-westerly direction.
2949.	Meganlis Park, Dromore, County Down (south-east side) – from a point 35 metres south-west of its junction with Gallows Street for a distance of 6 metres in a south-westerly direction.
2950.	Castleview, Gilford (north side) – from a point 27 metres east of its junction with Castle Hill for a distance of 6 metres in an easterly direction.
2951.	Whinny Hill, Gilford (south-east side in front of No. 3 Hillcrest Villas) – from a point 24 metres south-west of its junction with Copperfields for a distance of 6 metres in a south-westerly direction.
2952.	Rooney Park, Kilkeel (south-west side in front of No. 36) – from a point 115 metres north-west of its junction with Rooney Road for a distance of 3 metres in a north-westerly direction.
2953.	Ferris Avenue, Larne, (east side) – from a point 120 metres north-east of its junction with Moyle Parade for a distance of 5.5 metres in an easterly direction.
2954.	Greenmount Gardens, Lisburn (south-west side) – from a point 57 metres southwest of its junction with Ballynahinch Road for a distance of 3 metres in a southwesterly direction.

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking places referred to in Article 2(2)(a).
