Citation and commencement

1. This Order may be cited as The Prohibition of Waiting (Schools) (Amendment) Order (Northern Ireland) 2021 and shall come into operation on 31st August 2021.

Amendment

2. The Prohibition of Waiting (Schools) Order (Northern Ireland) 2021(**d**) is amended by the addition to Schedule 2 of the following items—

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Prohibition of Waiting (Schools) Order (Northern Ireland) 2021 ("the Order") by the addition to Schedule 2 of the items specified in Article 2.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
