# The Parking and Waiting Restrictions (Rathfriland) (Amendment) Order (Northern Ireland) 2021

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4) and 13(1) of The Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide a suitable parking place for vehicles on the length of the road specified in Article 2.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to The Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department, in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking place the particulars specified in paragraph 3(2) of that Schedule.

One written objection has been received and duly considered and no other representation has been received.

#### Citation and commencement

**1.** This Order may be cited as The Parking and Waiting Restrictions (Rathfriland) (Amendment) Order (Northern Ireland) 2021 and shall come into operation on 10th January 2022.

**2.** The Parking and Waiting Restrictions (Rathfriland) Order (Northern Ireland) 2012(**a**) is amended by the addition to Schedule 1 of the following item—

"4. Downpatrick Street (south-west side) – from a point 15 metres south-east of its junction with Main Street for a distance of 46 metres in a south-easterly direction."
