## ROAD TRAFFIC AND VEHICLES

# The Waiting Restrictions (Glenarm) Order (Northern Ireland) 2022

Made---26th October 2022Coming into operation17th November 2022

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

#### Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Waiting Restrictions (Glenarm) Order (Northern Ireland) 2022 and shall come into operation on 17th November 2022.
  - (2) In this Order—

"medical practitioner" means a registered person within the meaning of the Medical Act 1983(d);

"postal packet" has the same meaning as in section 65(1) of the Postal Services Act 2011(e); and

"universal service provider" has the same meaning as in section 65(1) of the Postal Services Act 2011.

#### **Restriction of waiting**

**2.** Save as provided in Article 3, a person shall not cause or permit a vehicle to wait at any time on a length of road specified in the Schedule.

#### **Exceptions**

- **3.**—(1) Nothing in Article 2 shall render it unlawful for a person to cause or permit a vehicle to wait on the carriageway of a length of road specified in the Schedule where the person in control of it is prevented from proceeding by circumstances beyond that person's control or to avoid an accident or for so long as may be reasonably necessary to enable—
  - (a) a person to board or alight from a vehicle provided that such boarding or alighting does not cause the vehicle to wait in the same place for more than 2 minutes;
  - (b) the vehicle to be used in an emergency by a medical practitioner, or for fire and rescue, ambulance, police or customs purposes or the purposes of the security forces;
  - (c) the vehicle to be used by or on behalf of a universal service provider for the purposes of the delivery to, or collection from, premises situated adjacent to the length of road of postal packets;
  - (d) the vehicle, if it cannot conveniently be used for such purposes outside that length of road, to be used—
    - (i) in connection with any building, repair or demolition operations;
    - (ii) in connection with the removal of any obstruction to traffic;
    - (iii) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;
    - (iv) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of that undertaker's functions;
    - (v) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992(a) or a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996(b); or
    - (vi) in connection with the laying, erection, alteration or repair of any electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984(c).
- (2) For the purposes of paragraph (1)(a) a vehicle shall be deemed to wait in the same place for more than 2 minutes if any one part of the carriageway is below any part of the vehicle or its load (if any) throughout a period exceeding 2 minutes whether or not the vehicle is moved during that period.

#### **SCHEDULE**

Article 2

## WAITING RESTRICTIONS IN GLENARM – No Waiting at any Time (Loading and Unloading not permitted)

- 1. Bridge Street (south-west side) from its junction with Munie Road for a distance of 165 metres in a south-easterly direction.
- 2. Munie Road (south-west side) from its junction with Bridge Street for a distance of 53 metres in a north-westerly direction.
- 3. Munie Road (south-west side) from a point 67.5 metres north-west of its junction with Bridge Street for a distance of 57 metres in a north-westerly direction.
- 4. New Road (north-west side) from a point 15 metres north-east of its junction with Bridge Street for a distance of 81 metres in a north-easterly direction.

#### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order prohibits vehicles waiting at any time (loading and loading not permitted) on a length of road specified in the Schedule.

Vehicles are excepted from the prohibition in certain circumstances (Article 3).

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of this Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
