The Whitehouse Road, Londonderry (Abandonment) Order (Northern Ireland) 2022

Made - - - - 26th October 2022

Coming into operation - 5th December 2022

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic to abandon the area of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Whitehouse Road, Londonderry (Abandonment) Order (Northern Ireland) 2022 and shall come into operation on 5th December 2022.
- (2) In this Order "the developer" means Braidwater Limited whose registered office is situated at 25F Longfield Road, Eglinton, Co. Londonderry, BT47 3PY.

Application

- **2.** The developer shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on completion of the works the area of road described in the Schedule shall be abandoned.
- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus along, across, over or under the abandoned areas of road shall be removed.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be extinguished.
