# The Parking Places (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2022

Made	-	10th February 2022
Coming into operation	-	4th March 2022

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

#### **Citation and commencement**

This Order may be cited as the Parking Places (Disabled Persons' Vehicles) (Amendment No.
Order (Northern Ireland) 2022 and shall come into operation on 4th March 2022.

### Amendments

"2991.	Cregagh Gardens, Armagh (north side of a parking area to the rear of No. 8) - from a point 97 metres south and then east of its junction with Monaghan Road for a distance of 5.4 metres in an easterly direction.	
2992.	Maryville Crescent, Banbridge (north-west side in the lay-by in front of No. 6) - from a point 29 metres north-east of its junction with Maryville Drive for a distance of 6 metres in a north-easterly direction.	
2993.	Nevis Avenue, Belfast (north-east side) - from a point 55 metres north-west of its junction with Irwin Avenue for a distance of 5.5 metres in a north-westerly direction.	
2994.	Chapel Road, Camlough (south side in front of No. 44 St Malachy's Park) - from a point 27 metres north-west of its junction with Keegall View for a distance of 6 metres in a north-westerly direction.	
2995.	Thornhill Drive, Dromore, County Down (north-east side of a lay-by to the side of No. 27) - from a point 85 metres north-west of its junction with Maypole Park for a distance of 3 metres in a north-westerly direction.	
2996.	Rooney Park, Kilkeel (south-west side to the side of No. 29) - from a point 83 metres south-west of its junction with Rooney Road for a distance of 3 metres in a south-easterly direction.	
2997.	O'Reilly Park, Killeen (north-east side to the side of No. 27) - from a point 57 metres south-west of its southern junction with Clontigora Road for a distance of 6 metres in a south-easterly direction.	
2998.	Greenhaw Road, Londonderry (south side in a lay-by) - from a point 40 metres east of its junction with Racecourse Road for a distance of 6 metres in an easterly direction.	
2999.	Seymour Gardens, Caw, Londonderry (north-west side in a parking area to the side of No. 29) - from a point 58 metres south-east and then 52 metres south-west of its junction with Kinsale Park for a distance of 3 metres in a south-westerly direction.	
3000.	Sperrin Park, Caw, Londonderry (north-west side in a layby in front of Nos. 233 and 235) (2 bays) - from a point 84 metres north-east of its junction with Kinsale Park for a distance of 12 metres in a north-easterly direction.	
3001.	Barcroft Park, Newry (north-west side in front of No. 9) - from a point 30 metres south-east of its most easterly junction with Dorans Hill for a distance of 5.5 metres in a south-easterly direction.	
3002.	College Gardens, Newry (south-west side in front of No. 25) - from a point 159 metres north-west of its junction with Armagh Road for a distance of 6 metres in a north-westerly direction.	
3003.	Raymond Kelly Park, Newry (north-east side) - from a point 40 metres north-west of its junction with Dorans Hill for a distance of 6 metres in a north-westerly direction.	
3004.	Rosconnor Place, Rathfriland (south-east side) - from a point 29 metres south-west of its junction with Downpatrick Street for a distance of 6 metres in a south- westerly direction.	
3005.	Seapatrick Avenue, Seapatrick (south-west side) - from a point 38 metres north- west of its junction with Seapatrick Road for a distance of 6 metres in a north- westerly direction.	
3006.	Main Street, Trillick (south-east side) - from a point 62.5 metres north-east of its junction with Greenan Road for a distance of 6 metres in a north-easterly direction.	

## **EXPLANATORY NOTE**

### (This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking places referred to in Article 2(2). This Order also corrects a drafting error in The Parking Places on Roads and Waiting Restrictions (Dungannon) (Amendment) Order (Northern Ireland) 2021 (Article 3).
