The Foreglen Road, Dungiven (Abandonment) Order (Northern Ireland) 2022

Made - - - - 25th February 2022

Coming into operation - 31st March 2022

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order proposes to abandon the area of road as described in the Schedule as it is not necessary.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation and commencement

1. This Order may be cited as the Foreglen Road, Dungiven (Abandonment) Order (Northern Ireland) 2022 and shall come into operation on 31st March 2022.

Application

- **2.** The area of road described in the Schedule is abandoned.
- **3.**—(1) All existing cables, wires, pipes or other apparatus owned by Northern Ireland Water Limited and Northern Ireland Fire and Rescue Service placed along, across, over or under the abandoned area of road shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.
- **4.**—(1) All other existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be removed.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be extinguished.
