The Vennel, Bangor (Abandonment) Order (Northern Ireland) 2022

Made - - - - 25th February 2022

Coming into operation - 31st March 2022

The Department for Infrastructure (a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order proposes to abandon the areas of road described in the Schedule as they are not necessary.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

One objection has been received and duly considered and no other representations have been received.

Citation and commencement

1. This Order may be cited as the Vennel, Bangor (Abandonment) Order (Northern Ireland) 2022 and shall come into operation on 31st March 2022.

Application

- **2.** The areas of road described in the Schedule are abandoned.
- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus owned by DfI Roads Street Lighting placed along, across, over or under the abandoned area of road shall be relocated.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be extinguished.
- **4.**—(1) All other existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

AREAS OF ROAD TO BE ABANDONED

Two areas of road totalling 506 square metres at The Vennel, Bangor consisting of—

- (a) 159 square metres of road from its junction with Southwell Road; and
- (b) 347 square metres of road comprising footpath from its junction with Queen's Parade
