The Department in accordance with Article 68(4) of that Order is of the opinion that the lengths of the road described in the Schedule are not necessary for road traffic.

#### Citation and commencement

**1.** This Order may be cited as the Market Square, Lisburn (Stopping-Up) Order (Northern Ireland) 2023 and shall come into operation on 1st February 2024.

- **2.**—(1) The lengths of road described in the Schedule shall be stopped-up to motor vehicles at the lines specified therein.
- (2) The Department shall carry out such works as it considers necessary to prevent or restrict to such extent as the Department thinks fit, access to the lengths of road described in the Schedule by motor vehicles.
- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the road shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

#### LENGTHS OF ROAD TO BE STOPPED UP TO MOTOR VEHICLES

- 1. Market Square, Lisburn (north-west side) at a line at its junction with Market Square North for a distance of 16.7 metres in an easterly direction, more particularly delineated and shown by the line marked a-b on Map No. IN1/22/574528.
- 2. Market Square, Lisburn (south-west side) at a line at its junction with Market Square South for a distance of 15.2 meters in an easterly direction, more particularly delineated and shown by the line marked c-d on Map No. IN1/22/574528.
