SECT. IX.

Of Fraudulent Preferences and Alienations.

BINNING against FARQUHAR.

1666. November 15.

No 68. A father difponed to his fon. The fon difponed again to his brother-inlaw. In fo far as the father was bound in the fon's contract of marriage, his disposition was good to the fon; but the fon's difpofition, in prejudice of creditors, if not proven to be onerous, would be deemed fraud. ulent.

A DISPOSITION being made by a father in favours of a fon; and thereafter the fame lands being difponed by the fon in favours of his brother-in-law.: The faid rights were queftioned by a creditor, as being fraudulent; being difponed by the fon's contract of marriage; which, though onerous as to provifions in favours of the wife, is not fo as to the fon, whom the father could not advance, or provide in prejudice of the creditors: But it was *alleged*, that the difpofition made by the fon, was for an onerous caufe; and, by the act of Parliament, though a right fhould be found fraudulent, yet a third party acquiring *bona fide*, by the act of Parliament is fecured; and his right cannot be queflioned, unlefs he be *particeps fraudis*, or acquire the fame without an onerous caufe, which, by the act of Parliament, is only probable *scripto vel juramento*.

Yet the LORDS inclined to reduce the right granted by the fon, unlefs it were offered to be proven, that it was for an onerous caufe; in refpect of feveral prefumptions alledged and informed by the purfuer: And, before anfwer, as to the relevancy, ordained both parties to condefcend upon their prefumptions *binc inde*, of fraud, or the caufe onerous for the granting of the faid right, and to prove the condefcendence. I have ever thought, that the practice of the Lords to ordain parties to prove before anfwer, as it is late, is accompanied with many inconveniencies; feeing by fuch acts, which are not of litifconteftation, proceffes are ftill kept loofe; and after that irregular way of probation, the debate of relevancy is again refumed, to the great vexation both of parties and Lords; and after the Lords interlocutor of relevancy, there may be again litifconteftation: So that upon the matter there are two litifconteftations in one caufe.

It being again debated, What the certification fhould be in fuch acts, viz. whether the allegeance fhould be holden as not proponed; or that the Lords fhould advife: Which in effect is no certification.

THE LORDS were not clear to determine; which is a great informality, and a preffing reafon against that anomolous way.
