ed to her by the purfuer's father, by her contract of marriage; which the faid purfuer's father is obliged to warrant to her; and the purfuer being bred up with a writer, and now a man of perfect age, he ought to do for himfelf; at the leaft he ought to feek his father, who, in nature, is bound for aliment to his fon. THE LORDS, in refpect of the allegeance, affoilzied the relict, and found no modification ought to be granted, of her part of the lands liferented by her; for which they found, That the acts of Parliament, which were the grounds of this purfuit, could be no warrant to fuftain this action againft her: And as to the father, albeit the father, by the law of nature, is obliged to nourifh his fon *quoad alimentum*; yet they found, That this act of Parliament could not be any ground to maintain this action againft the father, to compel him to pay any thing out of that part of his liferent lands, for his fon's entertainment, except that he might fnew fome other reafon to induce it, as that the father had kythed fome unnatural and inhuman dealing to the fon, and had refufed him his ordinary maintenance,

_____ STIRLING, fon to Commiffary Stirling, purfues for a modification of an aliment, out of the liferent of Helen Heriot, his father's wife, as having the liferent of the whole eftate.

THE LORDS fultained not the aliment, in refpect the defender's liferent was very mean, and the purfuer was major, and kept a brewery; and the kept one of his children; and that he was not *frugi aut bone fame*.

*** Gosford flates the fame cafe thus :

JAMES STIRLING purfuing Helen Heriot, his mother-in-law, for an aliment upon that ground, that by her liferent and infeftments, granted to creditors, the whole rent of his father's effate was exhausted.—It was alleged for the defender, That her liferent was only four chalders of victual, and 100 and odd pounds Scots; which was no more than a competent aliment to herfelf; as likewife that the purfuer was now thirty years of age, and had entertained himfelf as a foldier, or by brewery; and had left to him, by his uncle, the fum of L. 8000 Scots.—The LORDS found the allegeance fo qualified, relevant to elide the purfuit; notwithftanding it was anfwered, that the faid fum left by his uncle, was due by his father, to whom, he being heir, all other creditors were preferred, whereby the whole effate was exhausted.

AITON against COLVIL.

No 12. An aliment modified to an heir out of his ftep-mother's jointure, although he was major, and an advocate, but did not earn a fubfiltence by his profeffion.

MR WILLIAM AITON, of that Ilk, purfues Dame Margaret Colvil, his motherin-law, for an aliment, in refpect his father's eftate, being 47 chalders of victual, is overburdened with her liferent of 24 chalders, and 40,000 merks of provision to her children, and other 40,000 merks of extraneous debts; fo there was no fufficient effate left to fuffain the heir -- Allaged, This process is either founded on the flatute of James V. for fuperiors alimenting their ward-vaffals, or *fuper* jure nature, where one purfues his own mother; none of which holds here, the being a stranger to him, and fecured in a jointure by her contract of marriage, which cannot be diminified contra fidem tabularum nuptialium.-Anfwered, Much of our law is introduced by cultom, time out of mind; and this of alimenting heirs is one of them; and much ftronger than our positive ftatutes, and has been ever fustained against step-mothers having exorbitant liferents.-----THE LORDS repelled the defence, in respect of the answer.—2do, Alleged, These aliments were only given in favour of minors, who had no other way of fuftenance; but where they were come to age, and had a calling, they were never granted; for that were to encourage idlenes; but fo it is, the purfuer here is both major and an advocate. And Durie, in two feveral decisions, 11th February 1636, Sibbald, No 9. Jupra; and 21st July 1636, L. Ramornay, No 10. Jupra-tells, that the Lords refused aliments to fuch as had callings .- Anfwered, The name of an employment will not afford a man bread; neither is the race always to the fwift, nor the battle to the ftrong ; et officium nemini debet effe damnofum : And we have known many advocates who have rifen to a great eminency and practice, who, at the beginning, have had little or no employment. And the cafes cited do not meet; for, in the first, the grandfather was alive, who had a liferent referved; and it was thought as reafonable he fhould bear the aliment as the mother. And
