HELEN ADAM against Sir Andrew Lauder of Fountainhall.

No 26. The proprietor of an entailed eflate, found obliged to aliment his fon's wire.

SIR ANDREW LAUDER'S eldest son, a lad of twenty, living in familia with his father, made a runaway marriage with Helen Adam, a servant maid of the house; and immediately after quitted her, and went off to the East Indies, where he settled.

Helen Adam brought an action of aliment against Sir Andrew, his father, posfessed of an entailed estate of L. 250 clear rent.

Objected by Sir Andrew, 1mo, He has but a fmall effate, and eleven younger children, without one penny to give them, except what he can gather by his annual favings, feeing his effate is entailed. In fuch a fituation, the law could not mean to subject the father to the aliment of his eldest son's wife.

2do, At any rate, the fon is primarily liable, the father only fubsidiarie; but the pursuer, as yet, has not brought any action of aliment against her husband.

THE LORDS found the defender liable to aliment.

GEORGE STEWART against Mrs Charlotte Campbell.

No 27.
Aliment not exigible by an heir of entail, from an annuitant on the effate.

James Stewart of Stewarthall, executed an entail of his estate, with the usual clauses, and likewise under this condition; 'That the heirs of entail 's should be obliged to apply L. 100 yearly of the rents towards the extinction of the debts with which the estate was affected.'

He afterwards married Mrs Charlotte Campbell; and, in virtue of a power referved in the entail, he fettled on her a jointure of L. 130 per annum.

George Stewart, though a very distant relation, succeeded as first heir of entail; when he found the situation of the estate such, that, after payment of the jointure, the rents of the lands, which amounted to L. 246, fell considerably short of the other annual burdens. He had no separate sunds; nor did he practise any calling to earn his subsistence; for, though he had been bred a failor, and was still a young man, he had withdrawn himself from that way of life.

He therefore claimed an aliment from the widow, as liferentrix of fo large a part of the produce of the estate; and having raised an action on that ground, is was

Pleaded for the defender: The defender is, by her marriage-contract, an onerous creditor on the estate, and is not bound to aliment the pursuer, her debtor.
