The Fees in the Registers of Scotland (Consequential Provisions) Amendment Order 2013

Made	21st February 2013
Laid before the Scottish Parliament	25th February 2013
Coming into force	1st April 2013

The Scottish Ministers make the following Order in exercise of the powers conferred by section 25 of the Land Registers (Scotland) Act $1868(\mathbf{a})$ and section 117 of the Land Registration etc. (Scotland) Act $2012(\mathbf{b})$ and all other powers enabling them to do so.

Citation and commencement

1. This Order may be cited as the Fees in the Registers of Scotland (Consequential Provisions) Amendment Order 2013 and comes into force on 1st April 2013.

Amendment of the Fees in the Registers of Scotland Order 1995

2. In the Fees in the Registers of Scotland Order 1995(c), omit Part XI, paragraph 4 (other services)(**d**) of the Schedule.
