ROAD TRAFFIC

The A90 Trunk Road (Northbound Slip Road from B980 Castlandhill Road) (Temporary Prohibition on Use of Road and Temporary Speed Restrictions) Order 2014

Made - - - 13th January 2014

Coming into force - - 20th January 2014

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the lengths of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near those lengths of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A90 Trunk Road (Northbound Slip Road from B980 Castlandhill Road) (Temporary Prohibition on Use of Road and Temporary Speed Restrictions) Order 2014, comes into force on 20th January 2014 and ceases to have effect on 31st December 2014.

Prohibition on use of road

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the Part 1 of the Schedule to this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of the traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(**b**).

Speed restriction

- **3.** No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of a length of road, specified in Part 2 of the Schedule to this Order at a speed exceeding 50mph miles per hour when that restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002(**a**).
- **4.** No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of a length of road, specified in Part 2 of the Schedule to this Order at a speed exceeding 40mph miles per hour when that restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002(**a**).

Exemptions

- **5.** No prohibition imposed by this Order applies to vehicles being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.
- **6.** No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(**b**) when used in accordance with regulation 3(5) of those Regulations.

SCHEDULE

Article 2

PART 1

SPECIFIED LENGTH OF ROAD

That length of the M90/A90 Edinburgh - Fraserburgh Trunk Road being the northbound on slip road from the B980 Castlandhill Road at Ferrytoll, a distance of 195 metres or thereby.

PART 2

Articles 3 and 4

SPECIFIED LENGTH OF ROAD

That length of road being the temporary northbound on slip road from the B980 Castlandhill Road at Ferrytoll to the M90/A90 Edinburgh - Fraserburgh Trunk Road, a distance of 90 metres or thereby.
