ROAD TRAFFIC

The A8 Trunk Road (Chapelhall) (Temporary Prohibition on Use of Road) Order 2014

The Scottish Ministers make the following Order in exercise of the powers conferred by section 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act $1984(\mathbf{a})$ and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the Schedule should be prohibited or restricted because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A8 Trunk Road (Chapelhall) (Temporary Prohibition on Use of Road) Order 2014, comes into force on 20th October 2014 and ceases to have effect on 10th November 2014.

Prohibition on use of road

2. No person may use, or permit the use of, any vehicle on the length of road, or a part of parts of the length of road, specified in the Schedule to this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(**b**).

Exemptions

3. No prohibition imposed by this Order applies to—

(a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or

Article 2

That length of the M8/A8 Edinburgh - Greenock Trunk Road, at Chapelhall, being the westbound off slip, from the point at which it leaves the carriageway, to both points where it meets the carriageway of the northbound B799 Bo'Ness Road at Chapelhall.
