# **ROAD TRAFFIC**

# The A85 Trunk Road (Comrie) (Temporary Prohibition On Use of Road) Order 2014

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), and (2), 4(1) and 16A of the Road Traffic Regulation Act  $1984(\mathbf{a})$  and all other powers enabling them to do so.

In accordance with section 16A(2) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be restricted or prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that relevant event.

In accordance with section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for the event to be held otherwise than on a road.

In accordance with section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

#### Citation, commencement and cessation

**1.** This Order may be cited as the A85 Trunk Road (Comrie) (Temporary Prohibition On Use of Road) Order 2014, comes into force on 31st December 2014 and ceases to have effect on 2nd January 2015.

#### Prohibition on use of vehicles

**2.** No person may use or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the Schedule to this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(**b**).

### Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used for facilitating the holding of the relevant event.

## SCHEDULE

Article 2

## SPECIFIED LENGTH OF ROAD

That length of the A85 Perth – Lochearnhead Trunk Road from the point where it meets the extended centre line of the access road to Tomperran, Comrie, in a westerly direction through Drummond Street, Dunira Street, Dundas Street and Burrell Street, Comrie, to the point where it meets the extended centre line of the west access road to Twenty Shilling Wood Caravan Site, Comrie, a distance of 2.496 kilometres or thereby.
