ROAD TRAFFIC

The M90/A90 Trunk Road (Kingsway, Dundee) (50mph and 40mph Speed Limit) Order 2015

Made - - - - 30th January 2015

Coming into force - - 9th February 2015

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 84(2) of the Road Traffic Regulation Act 1984, Scottish Ministers have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b).

Citation and commencement

1. This Order may be cited as the M90/A90 Trunk Road (Kingsway, Dundee) (50mph and 40mph Speed Limit) Order 2015 and comes into force on 9th February 2015.

Speed restriction

- **2.** No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in Part 1 of the Schedule to this Order.
- **3.** No person may drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in Part 2 of the Schedule to this Order.

Revocation

4. The Perth-Dundee Trunk Road (A972) (Kingsway, Dundee) (50 mph Speed Limit) Order 1989(c) is revoked.

5. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

PART 1

1. The M90/A90 Edinburgh – Fraserburgh Trunk Road from a point at the southwest side of the roundabout situated at the junction of the M90/A90 Edinburgh – Fraserburgh Trunk Road and Myrekirk Road in an easterly direction, to the centre of the King's Cross Grade Separated Interchange, and junction with the B960 (Clepington Road) Dundee, a distance of 3350 metres or thereby.

PART 2

2. The M90/A90 Edinburgh – Fraserburgh Trunk Road from a point at the centre of the King's Cross Grade Separated Interchange, and junction with the B960 (Clepington Road) Dundee in an easterly direction, to the immediate west side of the junction with the A92/A972 Kirkcaldy – Dundee Trunk Road (Kingsway) and the M90/A90 Edinburgh – Fraserburgh Trunk Road (Forfar Road) Dundee, a distance of 2960 metres or thereby.
