The A85 Trunk Road (East Huntingtower to Lochty) (40mph Speed Limit) Order 2016

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) and 124(1)(d) of and paragraph 27 of Schedule 9 to the Road Traffic Regulation Act $1984(\mathbf{a})$ and all other powers enabling them to do so.

In accordance with section $84(2)(\mathbf{b})$ of that Act, they have given public notice of their intention to make this Order and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(\mathbf{c}).

Citation and commencement

1. This Order may be cited as the A85 Trunk Road (East Huntingtower to Lochty) (40mph Speed Limit) Order 2016 and comes into force on 11th March 2016.

Speed restriction

2. No person may drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in the Schedule to this Order.

Revocation

3. The A85 Trunk Road (West Huntingtower/Lochty) (40mph Speed Limit) Order 2001(**d**) is revoked.

Article 2

SPECIFIED LENGTH OF ROAD

That section of the A85 Perth – Lochearnhead Trunk Road from a point (at Ordnance Map coordinates 308256,724892) 15 metres or thereby east of where it meets the extended centre line of the eastern access road to Huntingtower Castle in a westerly direction to a point (at Ordnance Map coordinates 306396, 725130) 220 metres or thereby west of where it meets the extended centre line of the Almondbank Road, a distance of 1895 metres or thereby.
