# The A84 Trunk Road (Balquhidder Station) (50mph Speed Limit) Order 2016

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act  $1984(\mathbf{a})$  and all other powers enabling them to do so.

In accordance with section  $84(2)(\mathbf{b})$  of that Act, they have given public notice of their intention to make this Order and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(c).

### Citation and commencement

**1.** This Order may be cited as the A84 Trunk Road (Balquhidder Station) (50mph Speed Limit) Order 2016 and comes into force on 29th January 2016.

#### **Speed restriction**

**2.** No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in the Schedule to this Order.

### Exemption

**3.** No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(**d**) when used in accordance with regulation 3(5) of those Regulations.

## SCHEDULE

Article 2

## SPECIFIED LENGTH OF ROAD

That length of the A84/A85 Stirling to Crianlarich Trunk Road from a point (at Ordnance Map coordinates 256690,720658) 340 metres or thereby north east of its junction with the extended centre line of the C33 Kingshouse and Balquhidder road in a north easterly direction to a point (at Ordnance Map coordinates 257732,721325) 80 metres or thereby north east of its junction with the extended centre line of the access road leading to Beech Tree Cottage, a distance of 1.257 kilometres or thereby.
