ROAD TRAFFIC

The A85 Trunk Road (Perth Road to James Square, Crieff) (Temporary Prohibition on Use of Road) Order 2016

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 16A of the Road Traffic Regulation Act $1984(\mathbf{a})$ and all other powers enabling them to do so.

In accordance with section 16A(2) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that relevant event.

In accordance with section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for the event to be held otherwise than on a road.

In accordance with section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A85 Trunk Road (Perth Road to James Square, Crieff) (Temporary Prohibition on Use of Road) Order 2016, comes into force on 21st August 2016 and ceases to have effect on 22nd August 2016.

Prohibition on use of vehicles

2. No person may use or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the schedule to this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 8 (diagram 7105 - position of barrier to mark length of road closed or to guide traffic past an obstruction) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions $2016(\mathbf{b})$.

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used for facilitating the holding of the relevant event.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A85 Perth – Lochearnhead Trunk Road from a point 50 metres or thereby southwest of its junction with Rectory Road, Crieff in a generally south-westwards direction along Perth Road and East High Street and then westwards along High Street and James Square to a point 25 metres or thereby east of the junction between West High Street and Academy Road, Crieff, a distance of 690 metres or thereby.
