ROAD TRAFFIC

The A87 Trunk Road (Portree) (40mph and 30mph Speed Limits and Part-Time 20mph Speed Limit) Order 2017

Made - - - - 24th January 2017

Coming into force - - 7th February 2017

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 82(2)(a), 83(1), 84(1)(a) and (c) and 124(1)(d) of, and paragraph 27 of schedule 9 of, the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 84(2)(**b**) of that Act, they have given public notice of their intention to make this Order and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(**c**).

Citation and commencement

1. This Order may be cited as the A87 Trunk Road (Portree) (40mph and 30mph Speed Limits and Part-Time 20mph Speed Limit) Order 2017 and comes into force on 7th February 2017.

Speed restrictions

- 2. No person may drive any motor vehicle at a speed exceeding—
 - (a) 40 miles per hour on the length of road specified in Part 1 of the schedule of this Order;
 - (b) 30 miles per hour on the length of road specified in Part 2 of the schedule of this Order; or
 - (c) 20 miles per hour on the length of road specified in Part 3 of the schedule of this Order, when that particular speed limit is identified as applying to that length of road by means of a traffic sign of the type described in item 1 (diagram 670 maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016(d).

Revocation

3. The A87 Trunk Road (Portree) (40mph and 30mph Speed Limits) and Portree High School (Part-time 20mph Speed Limit) Variation and Revocation Order 2011(a) is revoked.

Exemption

4. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(b) when used in accordance with regulation 3(5) of those Regulations.

SCHEDULE

Article 2

SPECIFIED LENGTHS OF ROAD

PART 1

That length of the A87 Invergarry - Kyle of Lochalsh - Borve Uig Trunk Road from a point 52 metres or thereby southeast of the extended centreline of the junction with Lisigarry Place northwestwards to a point 200 metres or thereby northwest of the point where it meets the extended centreline of Market Place, a distance of 514 metres or thereby.

PART 2

That length of the A87 Invergarry - Kyle of Lochalsh - Borve Uig Trunk Road from a point 434 metres or thereby south of the point where it meets the extended southern gable of Kerrysdale, Viewfield Road, Portree northwards, then north-westwards to a point 52 metres or thereby southeast of the extended centreline of the junction with Lisigarry Place, a distance of 2.37 kilometres or thereby.

PART 3

That length of the A87 Invergarry - Kyle of Lochalsh - Borve Uig Trunk Road from a point 34 metres or thereby south of the point where it meets the extended southern gable of The Manse, Viewfield Road, Portree northwards then north-westwards to a point 9 metres or thereby southeast of the point where it meets the extended southeast gable of No. 7, Viewfield Square, Portree a distance of 415 metres or thereby.
