The A738 Trunk Road (Stevenston Road, Pennyburn) (Redetermination of Means of Exercise of Public Right of Passage) Order 2017

Made - - - - 13th February 2017

Coming into force - - 27th February 2017

The Scottish Ministers have made the following order in exercise of the powers conferred by sections 2(1) and 152(2) of the Roads (Scotland) Act 1984(a) and all other powers enabling them to do so.

## Citation and commencement

**1.** This Order may be cited as the A738 Trunk Road (Stevenston Road, Pennyburn) (Redetermination of Means of Exercise of Public Right of Passage) Order 2017 and comes into force on 27th February 2017.

#### Redetermination of means of exercise of public right of passage

**2.** The lengths of road in Pennyburn specified in the schedule of this Order, at present footway, shall become cycle track, the right of passage being exercisable on pedal cycle and foot only.

# ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED

1. The length of the north footway of the A737/A738 St James Interchange – Kilwinning – Hawkhill Trunk Road at Stevenston Road from a point adjacent to the roundabout on the A78 Greenock – Prestwick Trunk Road, in a north-easterly direction for a distance of 92 metres or thereby, as shown by sawtooth hatching and numbered "1" on the plan numbered SCT2126/I/RO/01 and entitled the A738 Trunk Road (Stevenston Road, Pennyburn) (Redetermination of Means of Exercise of Public Right of Passage) Order 2017 signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF.

**2.** The length of the north footway of the A737/A738 St James Interchange – Kilwinning – Hawkhill Trunk Road at Stevenston Road from a point adjacent to the junction with Ashenyards Park Road, in a north-easterly direction for a distance of 65 metres or thereby, as shown by sawtooth hatching and numbered "2" on the plan numbered SCT2126/I/RO/01 and entitled the A738 Trunk Road (Stevenston Road, Pennyburn) (Redetermination of Means of Exercise of Public Right of Passage) Order 2017 signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF.
