ROAD TRAFFIC

The A90/A9000 Trunk Roads (Forth Road Bridge, and Queensferry Crossing and Forth Road Bridge Approach Roads) (Temporary Prohibitions on Use and Stopping, Bus Lane and Speed Restrictions) Order 2017

Made - - - - 21st November 2017

Coming into force - - 28th November 2017

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), (2) and (3), 4(1) and 14(1)(b) and (4) and 124(1)(d) of, and paragraph 27 of schedule 9 of, the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A90/A9000 Trunk Roads (Forth Road Bridge, and Queensferry Crossing and Forth Road Bridge Approach Roads) (Temporary Prohibitions on Use and Stopping, Bus Lane and Speed Restrictions) Order 2017, comes into force on 28th November and ceases to have effect on 31st December 2018.

Interpretation

- 2. In this Order—
 - "A90" means that part of the M90/A90 Edinburgh Fraserburgh Trunk Road at Ferrytoll Junction and from Dalmeny to South Queensferry;
 - "A9000" means the A9000 Dalmeny Inverkeithing Trunk Road formerly part of the A90;

"bridge" means that part of the A9000 known as the Forth Road Bridge from a point north of the bridge at Ordnance Survey grid reference NT 312585 680782 to a point south of the bridge at Ordnance Survey grid reference NT312468 678252, a distance of 2530 metres or thereby;

"bridge operator" means the person appointed by the bridge authority for the bridge to manage and maintain the bridge;

"carriageway" means that part of the road which is provided for the regular passage of vehicular motor traffic along the road;

"certified direct access instructor" has the meaning in regulation 64(2) of the Motor Vehicles (Driving Licences) Regulations 1999(a);

"cycle track" means that part of the road which is provided for the regular passage of pedal cycles along the road;

"footway" means that part of the road which is provided for the regular passage of pedestrians along the road;

"M90" means that part of the M90/A90 Edinburgh – Fraserburgh Trunk Road from Ferrytoll Junction to Queensferry Junction;

"pedal cycle" means a cycle whose motive power is provided solely by the legs of its rider or riders or which complies with requirements specified in Regulation 4 of the Electrically Assisted Pedal Cycles Regulations 1983(b);

"pedestrian" means the class of traffic set out in Class IX of the classes of traffic for the purposes of special roads in schedule 3 of the Road (Scotland) Act 1984(c);

"provisional licence" means a licence of the type described in section 97(2) and (3) of the Road Traffic Act $1988(\mathbf{d})$;

"roads" means the lengths of road described in the schedules of this Order.

Prohibition on use of road by vehicles

- **3.**—(1) No person may use, or permit the use of, any vehicle on the lengths of carriageway of the lengths of road described in Part 1 of schedule 1 of this Order.
 - (2) No prohibition imposed by paragraph(1) applies to:—
 - (a) a bus within the meaning given by section 1 of the Public Passenger Vehicles Act 1981(e);
 - (b) a taxi or a private hire car within the meaning given by section 23 of the Civic Government (Scotland) Act 1982(f);
 - (c) a motor bicycle with an engine cylinder capacity equal to or less than 125 cubic centimetres;
 - (d) a motor bicycle with an engine cylinder capacity greater than 125 cubic centimetres where that vehicle is being driven by the holder of an appropriate provisional licence under the supervision of a certified direct access instructor;
 - (e) a motor bicycle with an engine cylinder capacity greater than 125 cubic centimetres where that vehicle is being driven by a certified direct access instructor supervising the driving of a vehicle as described in sub-paragraph (d);
 - (f) an agricultural vehicle with or without a trailer (not being a vehicle within Class I or II of the classes of traffic for the purposes of special roads as set out in schedule 3 of the Roads

- (Scotland) Act 1984) within the meaning in section 3 of the Road Vehicles (Construction and Use) Regulations 1986(a), as amended;
- (g) a vehicle being used in an emergency or responding to an emergency for fire brigade, coastguard, ambulance or police purposes;
- (h) a vehicle being used for carrying out any maintenance, inspection, clearance, cleaning, repair, alteration or improvement of any part of the roads, the bridge structure or any other length of road managed and maintained by the bridge operators;
- a vehicle being used for the erection, laying, placing, maintenance, testing, alteration, repair or removal of any structure, works, apparatus in, on, under or over any part of the roads, the bridge structure or any other length of road managed and maintained by the bridge operator;
- (j) a vehicle being used in the investigation of an accident or incident which has occurred on or near the roads or bridge structure;
- (k) a vehicle being used in connection with a breakdown or mechanical defect or lack of fuel, oil or water, required for a vehicle, including in connection with the recovery and removal of that vehicle; or
- (l) a vehicle being used in accordance with any direction given by a constable in uniform or in accordance with the indication given by a traffic sign,

provided that all such exempt vehicles must be fitted with pneumatic tyres and not fitted with metal tyres, revolving runners, deflated tyres or tyres fitted with metal studs or spikes.

- (3) Any vehicle which would otherwise be exempt in accordance with paragraph 2 but does not conform with the Road Vehicles (Construction and Use) Regulations 1986 will not be exempt unless the roads authority has issued written consent to that vehicle using the road prior to the use of the road by that vehicle.
- **4.**—(1) No person shall use, or permit the use of, any vehicle on the lengths of road specified in Part 2 of schedule 1.
 - (2) No prohibition imposed by paragraph (1) applies to—
 - (a) a bus within the meaning given by section 1 of the Public Passenger Vehicles Act 1981;
 - (b) a pedal cycle;
 - (c) a vehicle being used in an emergency or responding to an emergency for fire brigade, coastguard, ambulance or police purposes;
 - (d) a vehicle being used for carrying out any maintenance, inspection, clearance, cleaning, repair, alteration or improvement of any part of that road; or
 - (e) a vehicle being used for the erection, laying, placing, maintenance, testing, alteration, repair or removal of any structure, works, apparatus in, on, under or over any part of that road.
- (3) No person shall use, or permit the use of, any vehicle on the length of road specified in Part 3 of schedule 1.
 - (4) No prohibition imposed by paragraph (3) applies to—
 - (a) a bus within the meaning given by section 1 of the Public Passenger Vehicles Act 1981;
 - (b) a taxi or private hire car within the meaning given by section 23 of the Civic Government (Scotland) Act 1982;
 - (c) a pedal cycle;
 - (d) a vehicle being used in an emergency or responding to an emergency for fire brigade, coastguard, ambulance or police purposes;
 - (e) a vehicle being used for carrying out any maintenance, inspection, clearance, cleaning, repair, alteration or improvement of any part of that road; or

(f) a vehicle being used for the erection, laying, placing, maintenance, testing, alteration, repair or removal of any structure, works, apparatus in, on, under or over any part of that road.

Prohibition on use of road by pedestrians and cyclists

- **5.**—(1) No person may use, or permit the use of, a pedal cycle on any part of the lengths of road described in schedule 2, except on the cycle track.
- (2) No pedestrian may use any part of the lengths of road described in schedule 2, except the footway.
- (3) No prohibition imposed by paragraph (1) or (2) applies to any person being present on or using any part of the roads—
 - (a) in accordance with any direction given by a constable in uniform or in accordance with the indication given by a traffic sign;
 - (b) where, in accordance with the permission given by a constable or the roads authority, they do so for the purpose of investigating any accident or incident which has occurred on or near the roads or bridge structure;
 - (c) where it is necessary for that person to do so to avoid or prevent an accident or to obtain or give help required as a result of an accident or emergency, and they do so in such manner as to cause as little danger and inconvenience as possible to other traffic on the roads;
 - (d) where they do so in the exercise of their duty as a constable or as a member of a fire brigade or of an ambulance service;
 - (e) where it is necessary for them to do so to carry out in an efficient manner—
 - (i) the maintenance, inspection, repair, cleaning, clearance, alteration or improvement of any part of the roads or bridge structure, or
 - (ii) the removal of any vehicle from any part of the roads, or
 - (iii) the erection, laying, placing, maintenance, testing, alteration, repair or removal of any structure, works or apparatus in, on, under or over any part of the roads or bridge structure; or
 - (f) where it is necessary for them to do so in connection with any inspection, survey, investigation or census which is carried out in accordance with any authority granted by the Scottish Ministers.

Restriction on Stopping

- **6.**—(1) No vehicle may stop or remain at rest on any part of the lengths of road specified in schedule 3.
- (2) Paragraph 1 does not apply where it is necessary for a vehicle which is being driven on the carriageway to be stopped—
 - (a) because of a breakdown or mechanical defect or lack of fuel, oil or water, required for the vehicle; or
 - (b) because of any accident, illness or other emergency; or
 - (c) to permit any person carried in or on the vehicle to recover or move any object which has fallen on the road; or
 - (d) to permit any person carried in or on the vehicle to give help which is required by any other person in any of the circumstances specified in the provisions of this paragraph.
- (3) Nothing in this article precludes a vehicle from stopping or remaining at rest on the carriageway while it is prevented from proceeding along the carriageway by the presence of any other vehicle or any person or object.

Bus lane

- 7.—(1) No person shall use, or permit the use of, any vehicle other than a bus to enter, proceed, or wait within the length of road specified in schedule 4.
- (2) For the purposes of paragraph (1) "bus" means a motor vehicle constructed or adapted to carry more than 23 seated passengers (exclusive of the driver).
 - (3) No prohibition imposed by paragraph (1) applies to—
 - (a) any vehicle being used in an emergency for fire brigade, coastguard, ambulance or police purposes;
 - (b) any vehicle being used in connection with the removal of any obstruction, or in connection with authorised works to or in that length of road; or
 - (c) any vehicle being used in connection with the maintenance, inspection, repair, cleaning, clearance, alteration or improvement of that length of road.

Speed restriction

- **8.**—(1) No person may drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Part 1 of schedule 5.
- (2) No person may drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in Part 2 of schedule 5.
- (3) No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road specified in Part 3 of schedule 5.
- (4) No person may drive any motor vehicle on the lengths of road, or a part or parts of those lengths of road, specified in Part 4 of schedule 5, at a speed exceeding 30 miles per hour or 40 miles per hour, as the case may be, when that particular speed restriction is identified as applying to those lengths of road, or part or parts of those lengths of road, by means of an appropriate traffic sign of the type described in item 1 (diagram 670 maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016(a).

Exemption

- **9.** No speed restriction imposed by this Order applies to—
 - (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(**b**) when used in accordance with regulation 3(5) of those Regulations; or
 - (b) vehicles being used in an emergency for coastguard purposes.

Variation

- **10.** The M90/A90 Trunk Road (Dalmeny to Masterton) (Temporary Prohibitions of Traffic, Pedestrians and Overtaking, Temporary Speed Restrictions and Temporary Bus Lanes) Order 2017(**c**) is varied in that—
 - (a) Articles 9 and 10 and Parts 7 and 8 of the schedule are omitted;

PART 1

SPECIFIED LENGTHS OF ROAD WITH RESTRICTED USE BY PERMITTED VEHICLES

- 1. That length of the southbound carriageway of the A9000 from its commencement at a point 145 metres or thereby south of the roundabout at Ferrytoll Junction to its junction with the A90 at Dalmeny at a point 300 metres or thereby west of the point where the A90 crosses Standingstane Road, Dalmeny, a distance of 5735 metres or thereby.
- **2.** That length of the A9000 being the southbound off-slip road at Echline Junction, a distance of 259 metres or thereby.
- **3.** That length of the A9000 being the southbound on-slip road at Echline Junction, a distance of 228 metres or thereby.
- **4.** That length of the A90 being the westbound off-slip road from its junction with the westbound carriageway of the A90 to its junction with the B800 Kirkliston to South Queensferry Road, a distance of 750 metres or thereby.
- **5.** That length of the A9000 being the northbound on-slip road at Echline Junction, a distance of 241 metres or thereby.
- **6.** That length of the northbound carriageway of the A9000 from the point where the northbound on-slip road joins the carriageway at Echline Junction to a point 30 metres or thereby south of its junction with the roundabout at Ferrytoll Junction, a distance of 4070 metres or thereby.
- **7.** That length of the A90 being the furthermost left hand lane of the eastbound carriageway from a point 300 metres or thereby west of the point where the A90 crosses Standingstane Road, Dalmeny to a point 320 metres or thereby east of the point where the A90 crosses Standingstane Road, Dalmeny, a distance of 620 metres or thereby.

PART 2

- **8.** That length of the A90 being the left hand lane of the circulatory carriageway of the roundabout at Ferrytoll Junction from the northbound on-slip road to the M90 to the southbound off-slip road from the M90, a distance of 100 metres or thereby.
- **9.** That length of the A90 being the left hand lane of the circulatory carriageway of the roundabout at Ferrytoll Junction from the junction with the B981 Hope Street to the southbound on-slip road to the M90, a distance of 40 metres or thereby.

PART 3

10. That length of the A90 being the left hand lane of the southbound on-slip road at Ferrytoll Junction from its commencement at the roundabout at Ferrytoll Junction southwards for a distance of 145 metres or thereby.

SCHEDULE 2

Article 5

SPECIFIED LENGTHS OF ROAD WITH RESTRICTED USE BY PEDESTRIANS AND CYCLISTS

- 1. The southbound carriageway of the A9000 being the bridge.
- **2.** The southbound carriageway of the A9000 from the bridge to its junction with the A90 at Dalmeny at a point 300 metres or thereby west of the point where the A90 crosses Standingstane Road, Dalmeny, a distance of 2330 metres or thereby.
- **3.** That length of the southbound on-slip road at Echline Junction from a point 15 metres or thereby from its junction with the roundabout at Echline Junction to its junction with the southbound carriageway of the A9000, a distance of 213 metres or thereby.
- **4.** That length of the A90 being the westbound off-slip road from its junction with the westbound carriageway of the A90 to its junction with the B800 Kirkliston to South Queensferry Road, a distance of 750 metres or thereby.
 - **5.** The northbound carriageway of the A9000 being the bridge.

SCHEDULE 3

Article 6

SPECIFIED LENGTH OF ROAD WITH A RESTRICTION ON STOPPING

- **1.** That part of the A9000 known as the Forth Road Bridge from a point north of the bridge at Ordnance Survey grid reference NT 312585 680782 to a point south of the bridge at Ordnance Survey grid reference NT 312468 678252, a distance of 2530 metres or thereby.
- **2.** That length of the A90 being the southbound off-slip road at Ferrytoll Junction from a point 30 metres or thereby north of its junction with the roundabout at Ferrytoll Junction to its junction with that roundabout, a distance of 30 metres or thereby.
- **3.** That length of the A90 being the southbound on-slip road at Queensferry Junction from its commencement at the roundabout at Queensferry Junction for a distance of 20 metres or thereby.
- **4.** That length of the A90 being the southbound on-slip road at Ferrytoll Junction from its commencement at the roundabout at Ferrytoll Junction southwards for a distance of 220 metres or thereby.

SCHEDULE 4 BUS LANE

Article 7

That length of the A90 being the left hand lane of the southbound off-slip road at Ferrytoll Junction from a point 30 metres or thereby north of its junction with the roundabout at Ferrytoll Junction to its junction with that roundabout, a distance of 30 metres or thereby.

PART 1

SPECIFIED LENGTHS OF ROAD TO WHICH A 30 MILE PER HOUR SPEED RESTRICTION APPLIES

- **1.** That length of the A90 being the southbound off-slip road at Queensferry Junction from a point 15 metres or thereby north of its junction with the roundabout at Queensferry Junction to its junction with that roundabout, a distance of 15 metres or thereby.
- **2.** That length of the A90 being the northbound off-slip road at Queensferry Junction from a point 20 metres or thereby south of the junction with the roundabout at Queensferry Junction to its junction with that roundabout, a distance of 20 metres or thereby.

PART 2

SPECIFIED LENGTH OF ROAD TO WHICH A 40 MILE PER HOUR SPEED RESTRICTION APPLIES

- **3.** That length of the A90 being the southbound off-slip road at Ferrytoll Junction from a point 30 metres or thereby north of its junction with the roundabout at Ferrytoll Junction to its junction with that roundabout, a distance of 30 metres or thereby.
- **4.** That length of the A90 being the circulatory carriageway of the roundabout at Ferrytoll Junction, a distance of 885 metres or thereby.
- **5.** That length of the northbound carriageway of the A9000 from a point 120 metres or thereby south of its junction with the roundabout at Ferrytoll Junction to its junction with that roundabout, a distance of 120 metres or thereby.

PART 3

SPECIFIED LENGTH OF ROAD TO WHICH A 50 MILE PER HOUR SPEED RESTRICTION APPLIES

- **6.** That length of the A90 being the southbound on-slip road at Ferrytoll Junction from its commencement at the roundabout at Ferrytoll Junction southwards for a distance of 220 metres or thereby.
- **7.** That length of the southbound carriageway of the A9000 from its commencement at a point 145 metres or thereby south of the roundabout at Ferrytoll Junction to a point 359 metres or thereby north of the northernmost abutment of the Forth Road Bridge, a distance of 515 metres or thereby.
- **8.** That length of the A90 being the westbound off-slip road from its junction with the westbound carriageway of the A90 to its junction with the B800 Kirkliston to South Queensferry Road, a distance of 750 metres or thereby.
- **9.** That length of the northbound carriageway of the A9000 from a point 359 metres north of the northernmost abutment of the Forth Road Bridge to a point 120 metres south of its junction with the roundabout at Ferrytoll Junction, a distance of 680 metres or thereby.

PART 4

SPECIFIED LENGTHS OF ROAD TO WHICH A 30 OR 40 MILE PER HOUR SPEED RESTRICTIONS APPLIES WHEN A SIGN SHOWS

- **10.** That length of the southbound carriageway of the A9000 from its commencement at a point 145 metres or thereby south of the roundabout at Ferrytoll Junction to its junction with the A90 at Dalmeny at a point 300 metres or thereby west of the point where the A90 crosses Standingstane Road, Dalmeny, a distance of 5735 metres or thereby.
- **11.** That length of the northbound carriageway of the A9000 from the point where the northbound on-slip road joins the carriageway at Echline Junction to a point 120 metres south of its junction with the roundabout at Ferrytoll Junction, a distance of 3980 metres or thereby.
