ROAD TRAFFIC

The A86 Trunk Road (Laggan) (Temporary Vehicle Width Restriction) Order 2018

Made - - - - 25th June 2018

Coming into force - - 2nd July 2018

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1), and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A86 Trunk Road (Laggan) (Temporary Vehicle Width Restriction) Order 2018, comes into force on 2nd July 2018 and ceases to have effect on 22nd October 2018.

Width Restriction

2. No person may use, or permit the use of, any vehicle on the length of road specified in the schedule if the width of the vehicle exceeds 2.4 metres when such restriction is identified as applying to any part or parts of that length of road by means of a traffic sign as prescribed in item 26 (diagram 629A – vehicles exceeding width indicated prohibited) of Part 2 of schedule 3 of the Traffic Signs Regulations and General Directions $2016(\mathbf{b})$.

Exemptions

- 3. No prohibition imposed by this Order applies to—
 - (a) a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes; or
 - (b) a vehicle being used for carrying out the works.

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A86 Spean Bridge - Kingussie Trunk Road from its junction with Balgowan Road, Laggan in an eastwards direction to its junction with the access road to 'the Bunkhouse at Roundhouse' at Uvie Farm, a distance of 3.5 kilometres metres or thereby.
