ROAD TRAFFIC

The A9 Trunk Road (McDiarmid Park) (Temporary 30mph Speed Restriction) Order 2018

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984(**a**) and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A9 Trunk Road (McDiarmid Park) (Temporary 30mph Speed Restriction) Order 2018, comes into force on 27th February 2018 and ceases to have effect on 28th February 2018.

Speed restriction

2. No person may use, or permit the use of, any vehicle on the lengths of road, or a part or parts of the lengths of road, specified in the schedule of this Order at a speed exceeding 30 miles per hour when a restriction is identified as applying to those lengths of road, or a part or parts of those lengths of road, by means of a traffic sign of the type described in item 1 (diagram 670 - maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions $2016(\mathbf{b})$.

Exemption

3. No speed restriction imposed by this Order applies to –

- (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations; or
- (b) vehicles being used in an emergency for coastguard purposes.

SCHEDULE

Article 2

SPECIFIED LENGTHS OF ROAD

1. That length of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road being the southbound off slip from the point where it diverges from the main carriageway to the point where it meets the circulatory carriageway of the Newhouse Roundabout (A85), a distance of 515 metres or thereby.

2. That length of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road being the southbound on slip from the point where it diverges from the circulatory carriageway of the Newhouse Roundabout (A85) to the point where it meets the main carriageway of the A9 southbound, a distance of 525 metres or thereby.
