### ROAD TRAFFIC

# The A83 Trunk Road (Inveraray) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2019

Made - - - - 25th April 2019

Coming into force - - 5th May 2019

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near those lengths of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

#### Citation, commencement and cessation

**1.** This Order may be cited as the A83 Trunk Road (Inveraray) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2019, comes into force on 5 May 2019 and ceases to have effect on 15 May 2019.

#### Prohibition on waiting, loading and unloading

2. No person may use, or permit the use of, any vehicle to wait, load or unload on the length of road, or a part or parts of the length of road, specified in the schedule when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of the traffic signs prescribed in items 19 (diagrams 636 – temporary prohibition of waiting except for loading and unloading) and 20 (diagram 636.1 – temporary prohibition of loading and unloading) of the sign table in part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016(b).

## **Exemptions**

- 3. No prohibition imposed by this Order applies to—
  - (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
  - (b) a vehicle being used for carrying out the works.

## **SCHEDULE**

Article 2

## SPECIFIED LENGTH OF ROAD

That length of the A83 Tarbet – Lochgilphead – Campbeltown Trunk Road from its junction with the entrance to The Avenue Car Park, Inveraray, in a generally northerly direction in Main Street South, Main Street West, Main Street East, then in a north westerly direction to its junction with Front Street East and Front Street West, a distance of 410 metres or thereby.
