The A90 Trunk Road (Aberdeen Western Peripheral Route) (Temporary Prohibitions and Restrictions) Amendment (No. 2) Order 2019

Made - - - - 28th January 2019

Coming into force - - 30th January 2019

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

Citation, commencement and cessation

1. This Order may be cited as the A90 Trunk Road (Aberdeen Western Peripheral Route) (Temporary Prohibitions and Restrictions) Amendment (No. 2) Order 2019, comes into force on 30 January 2019 and ceases to have effect on 30 June 2019.

Amendment of the A90 Trunk Road (Aberdeen Western Peripheral Route) (Temporary Prohibitions and Restrictions) (No. 2) Order 2018

- **2.**—(1) The A90 Trunk Road (Aberdeen Western Peripheral Route) (Temporary Prohibitions and Restrictions) (No. 2) Order 2018(**b**) is amended in accordance with paragraph (2).
 - (2) In article 12—
 - (a) renumber the existing text as paragraph (1),
 - (b) in sub-paragraph (a) of that paragraph, omit the words "as a constable or", and
 - (c) at the end, insert—
 - "(2) Articles 4 to 9 and 11 do not apply to a vehicle being used by any person in the exercise of their duty as a constable.
