ROAD TRAFFIC

The A90 Trunk Road (Aberdeen Western Peripheral Route and Balmedie to Tipperty) (Stonehaven to Tipperty) (Prohibition, 30mph and 40mph Speed Limit) Order 2019

Made - - - 17th June 2019

Coming into force - - 30th June 2019

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), and 84(1)(a) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section $84(2)(\mathbf{b})$ of that Act, they have given public notice of their intention to make this Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations $1987(\mathbf{c})$.

Citation and commencement

1. This Order may be cited as the A90 Trunk Road (Aberdeen Western Peripheral Route and Balmedie to Tipperty) (Stonehaven to Tipperty) (Prohibition, 30mph and 40mph Speed Limit) Order 2019 and comes into force on 30 June 2019.

Prohibition

2. A person must not by vehicle enter any length of road specified in Part 1 of the schedule at a point where a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 10 (diagram 616 – no entry for vehicular traffic) of the sign table in Part 2 of schedule 3 of the Traffic Signs Regulations and General Directions 2016(**d**).

Speed limit

- 3. A person must not drive any motor vehicle at a speed exceeding—
 - (a) 30 miles per hour on the lengths of road specified in Part 2 of the schedule, and

Exceptions

- **4.**—(1) Article 2 does not apply to any person being present on or using a length of road, or any part or parts of a length of road, specified in Part 1 of the schedule—
 - (a) for the purposes of Her Majesty's Coastguard in an emergency,
 - (b) in accordance with any direction given by a constable in uniform or in accordance with an indication given by a traffic sign,
 - (c) where, in accordance with any permission given by a constable or by the traffic authority, that person does so for the purpose of investigating any accident or incident which has occurred on or near the road,
 - (d) where it is necessary for that person to do so to—
 - (i) avoid or prevent an accident, or
 - (ii) obtain or give help required as a result of an accident or emergency,
 - and the person does so in such manner as to cause as little danger and inconvenience as possible to other traffic on the road,
 - (e) where it is necessary for that person to do so to carry out in an efficient manner—
 - (i) the maintenance, inspection, repair, cleaning, clearance, alteration or improvement of any part of the road,
 - (ii) the recovery and removal of any vehicle from any part of the road, or
 - (iii) the erection, laying, placing, maintenance, testing, alteration, repair or removal of any structure, works or apparatus in, on, under or over any part of the road,
 - (f) where it is necessary for that person to do so in connection with any inspection, survey, investigation or census which is carried out in accordance with any authority granted by the Scottish Ministers.
 - (2) Article 3 does not apply to any person using any—
 - (a) vehicle falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations, or
 - (b) vehicle for the purposes of Her Majesty's Coastguard in an emergency.

SCHEDULE

Articles 2 and 3

In this schedule "A90 Trunk Road" means the lengths of the M90/A90/A9000 Edinburgh – Fraserburgh Trunk Road constructed under the A90 (Aberdeen Western Peripheral Route) Trunk Road Order 2010(a) at Stonehaven and Blackdog and the M9/A90/M90 Trunk Road (Balmedie to Tipperty) (Trunking and Detrunking) Order 2012(b) between Balmedie and Tipperty.

PART 1

SPECIFIED LENGTHS OF ROAD - NO ENTRY

- 1. That length of the A90 Trunk Road being the southbound off slip road at Blackdog Junction from its junction with the circulatory carriageway of the roundabout at that Blackdog Junction to its junction with the southbound carriageway, a distance of 500 metres or thereby.
- **2.** That length of the A90 Trunk Road being the northbound off slip road at Newburgh Road Junction from its junction with the A975 Newburgh to Cruden Bay Road at that Newburgh Road Junction to its junction with the northbound carriageway, a distance of 694 metres or thereby.
- **3.** That length of the A90 Trunk Road being the southbound off slip road at Tipperty Junction from its junction with the B9000 Newburgh to Pitmedden Road at that Tipperty Junction to its junction with the southbound carriageway, a distance of 768 metres or thereby.

PART 2

SPECIFIED LENGTHS OF ROAD - 30 MPH SPEED RESTRICTION

- **4.** That length of the A90 Trunk Road being the northbound off slip road at Balmedie Junction leading to its junction with the circulatory carriageway of the west roundabout at that Balmedie Junction, a distance of 20 metres or thereby.
- **5.** That length of the A90 Trunk Road being the northbound on slip road at Balmedie Junction leading from its junction with the circulatory carriageway of the west roundabout at that Balmedie Junction, a distance of 305 metres or thereby.
- **6.** That length of the A90 Trunk Road being the southbound off slip road at Balmedie Junction leading to its junction with the circulatory carriageway of the east roundabout at that Balmedie Junction, a distance of 25 metres or thereby.
- 7. That length of the A90 Trunk Road being the southbound on slip road at Balmedie Junction leading from its junction with the circulatory carriageway of the east roundabout at that Balmedie Junction, a distance of 350 metres or thereby.

PART 3

SPECIFIED LENGTHS OF ROAD - 40 MPH SPEED RESTRICTION

8. That length of the A90 Trunk Road being the entire circulatory carriageway of the roundabout at Stonehaven North Junction, a distance of 219 metres or thereby.

- **9.** That length of the A90 Trunk Road being the southbound carriageway at Stonehaven North Junction leading from its junction with the circulatory carriageway of the roundabout at that Stonehaven North Junction, a distance of 231 metres or thereby.
- **10.** That length of the A90 Trunk Road being the northbound carriageway at Stonehaven North Junction leading to its junction with the circulatory carriageway of the roundabout at that Stonehaven North Junction, a distance of 231 metres or thereby.
- 11. That length of the A90 Trunk Road being the northbound off slip road at Stonehaven North Junction leading to its junction with the circulatory carriageway of the roundabout at that Stonehaven North Junction, a distance of 132 metres or thereby.
- 12. That length of the A90 Trunk Road being the southbound on slip road at Stonehaven North Junction leading from its junction with the A90 Trunk Road being the road that connects the B979 Netherley Road and the roundabout at that Stonehaven North Junction, a distance of 292 metres or thereby.
- 13. That length of the A90 Trunk Road being the northbound carriageway at Blackdog Junction leading to its junction with the circulatory carriageway of the roundabout at that Blackdog Junction, a distance of 10 metres or thereby.
- **14.** That length of the A90 Trunk Road being the southbound carriageway at Blackdog Junction leading from its junction with the circulatory carriageway of the roundabout at that Blackdog Junction, a distance of 10 metres or thereby.
- **15.** That length of the A90 Trunk Road being the entire circulatory carriageway of the roundabout at Blackdog Junction, a distance of 488 metres or thereby.
- **16.** That length of the A90 Trunk Road being the northbound on slip road at Blackdog Junction leading from its junction with the circulatory carriageway of the roundabout at that Blackdog Junction, a distance of 236 metres or thereby.
- 17. That length of the A90 Trunk Road being the southbound off slip road at Blackdog Junction leading to its junction with the circulatory carriageway of the roundabout at that Blackdog Junction, a distance of 268 metres or thereby.
- **18.** That length of the A90 Trunk Road being the northbound off slip road at Newburgh Road Junction leading to its junction with the A975 Newburgh to Cruden Bay Road at that Newburgh Road Junction, a distance of 456 metres or thereby.
- **19.** That length of the A90 Trunk Road being the southbound on slip road at Newburgh Road Junction leading from its junction with the A975 Newburgh to Cruden Bay Road at that Newburgh Road Junction, a distance of 331 metres or thereby.
