## **ROAD TRAFFIC**

# The A96 Trunk Road (Church Road, Keith) (Temporary Prohibition of Traffic) Order 2019

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2) and 4(1) and 16A of the Road Traffic Regulation Act 1984(**a**) and all other powers enabling them to do so.

In accordance with section 16A(2) of that Act, they are satisfied that traffic on the length of road specified in the Schedule to this Order should be prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that event.

In accordance with section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for that event to be held otherwise than on that length of road.

In accordance with section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order.

#### Citation, commencement and cessation

**1.** This Order may be cited as the A96 Trunk Road (Church Road, Keith) (Temporary Prohibition of Traffic) Order 2019, comes into force on 10 November 2019 and ceases to have effect on 11 November 2019.

#### Prohibition of use of vehicles

**2.** No person shall use or permit the use of any vehicle on the length of road, or a part or parts of a length of road, specified in the Schedule to this Order when such prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of one or more of the traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(**b**).

### Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes, or
- (b) a vehicle being used for facilitating the holding of the relevant event.

Article 2

That length of the A96 Aberdeen – Inverness Trunk Road known as Church Road, Keith, from its junction with Seafield Avenue, Keith continuing on through Moss Street, Keith to its junction with Bankers Lane, Keith, a distance of 395 metres or thereby.
