ROAD TRAFFIC

The A76 Trunk Road (High Street, Sanquhar) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2020

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act $1984(\mathbf{a})$ and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A76 Trunk Road (High Street, Sanquhar) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2020, comes into force on 23 July 2020 and ceases to have effect on 26 July 2020.

Prohibition on waiting, loading and unloading

2. No person may use, or permit the use of, any vehicle to wait, load or unload on the length of road, or a part or parts of the length of road, specified in the schedule of this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of one or both of the traffic signs of the type described in item 19 (diagram 636 - temporary prohibition of waiting except for loading and unloading) and item 20 (diagram 636.1 - temporary prohibition of loading and unloading) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016(**b**).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes, or
- (b) a vehicle being used for carrying out the works.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A76 Dumfries – Kilmarnock Trunk Road being the parking bays located on the northbound carriageway of High Street, Sanquhar from in front of number 36 High Street going in a northerly direction to the end of number 20 High Street, a distance of 40 metres or thereby.
