ROAD TRAFFIC

The M74/A74 Trunk Road (Junction 9) (Temporary 50mph Speed Restriction) Order 2023

Made - - - - 12th October 2023

Coming into force - - 23rd October 2023

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that the traffic on the lengths of road specified in the schedule should be restricted because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the M74/A74 Trunk Road (Junction 9) (Temporary 50mph Speed Restriction) Order 2023, comes into force on 23 October 2023 and ceases to have effect on 24 April 2024.

Speed restriction

2. No person may use, or permit the use of, any vehicle on the lengths of road, or a part or parts of the lengths of road, specified in the schedule at a speed exceeding 50 miles per hour when a restriction is identified as applying to those lengths of road, or a part or parts of those lengths of road, by means of a traffic sign of the type described in item 1 (diagram 670 – maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016(b).

Exemptions

- 3. No speed restriction imposed by this Order applies to—
 - (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations, or
 - (b) vehicles being used in an emergency for coastguard purposes.

SCHEDULE

Article 2

SPECIFIED LENGTHS OF ROAD

- **1.** That length of the M74/A74(M) Glasgow Carlisle Trunk Road being the northbound and southbound carriageways from a point 279 metres or thereby south of the centre point of the bridge at Strathaven Road, Kirkmuirhill, to a point 94 metres or thereby north of the centre point of the bridge at Carlisle Road, Blackwood, a distance of 1.5 kilometres or thereby.
- **2.** That length of the M74/A74(M) Glasgow Carlisle Trunk Road being the southbound off slip from the point where the slip road diverges from the main carriageway southwards to a point 45 metres or thereby south of the centre point of the bridge at Strathaven Road, Kirkmuirhill, a distance of 150 metres or thereby.
